

Traffic Death Toll

Lowest In Seven Years

CARSON CITY - Nevada has recorded its lowest July traffic death toll in seven years according to the Nevada Office of Traffic Safety.

There were 16 traffic fatalities in July...
the lowest total since 1969 when 14 persons were killed on Nevada highways.

The low toll follows three successive months

The low toll follows three successive months of high death totals bringing the number of traffic fatalities for the year to 127. The 127 figure represents 14 more deaths for this time period than in 1975, however it is still 24 less than in 1973 when 151 persons died in traffic accidents during the first seven months of the year.

John W. Borda, director of traffic safety, said this year's increase in the number of persons killed is primarily due to the high number of multiple fatal accidents in which more than one person died in each accident.

"There have actually been only 107 fatal traffic accidents this year, only six more than last year. Once again, that figure is still far below the 132 fatal accidents which occurred in 1973 (prior to the 55 miles per hour speed limit,"
