**Robert Penn Warren Drama**

Robert Penn Warren's "Brother to Dragons," poetic drama of man's confrontation with the dark side of his nature, will be rebroadcast on "Theater in America," Wednesday, Sept. 1 at 9 p.m. over PBS Channel 10. The program repeats Sunday, Sept. 5 at 10 p.m.

Warren, the only writer to have won the Pulitzer Prize both for fiction (All the King's Men) and for poetry (Poems: Promises 1954-56), plays a small role in the play, that of the writer's father.

The story illuminates an obscure event recorded in the early days of Kentucky statehood. In 1811, in the sparsely inhabited western part of that state, two brothers, Lilburn and Isham Lewis, brutally murdered a black slave in the family meathouse. Sadistic and apparently unprovoked as the crime was, it well might have become indistinguishable from the total sum of frontier violence but for one fact: the Lewis brothers were nephews of Thomas Jefferson.

Murder charges against the two were reported widely in the press, but so far as is known by historians, Jefferson never publicly acknowledged the horrible scandal that led to the end of his family in Kentucky.

**ABSENTEE BALLOT INFORMATION**

With the September 14th Primary just a few short weeks away the Clark County Election Department would like to advise all people who will be out of town or unable to go to the polls on Election Day that the time for requesting absentee ballots will end on Tuesday, September 7th, 1976.

Requests for absentee ballots for the Primary must be in writing. The requester must indicate his local address as well as the out of town address to which the absentee ballot should be sent.

For registered voters who are confined to their homes or for some reason are unable to go to the polling place, an absentee ballot can be sent to them at their local address.

For people who find themselves unexpectedly confined to Hospitals or Convalescent Homes and their stay will continue through Election Day, special pink absentee ballot request forms can be provided by the Hospitals' Public Relations staff upon request.

It is important to remember that all absentee ballots must be voted and returned to the Election Department prior to 7:00 P.M. on Election Day, Tuesday, September 14.

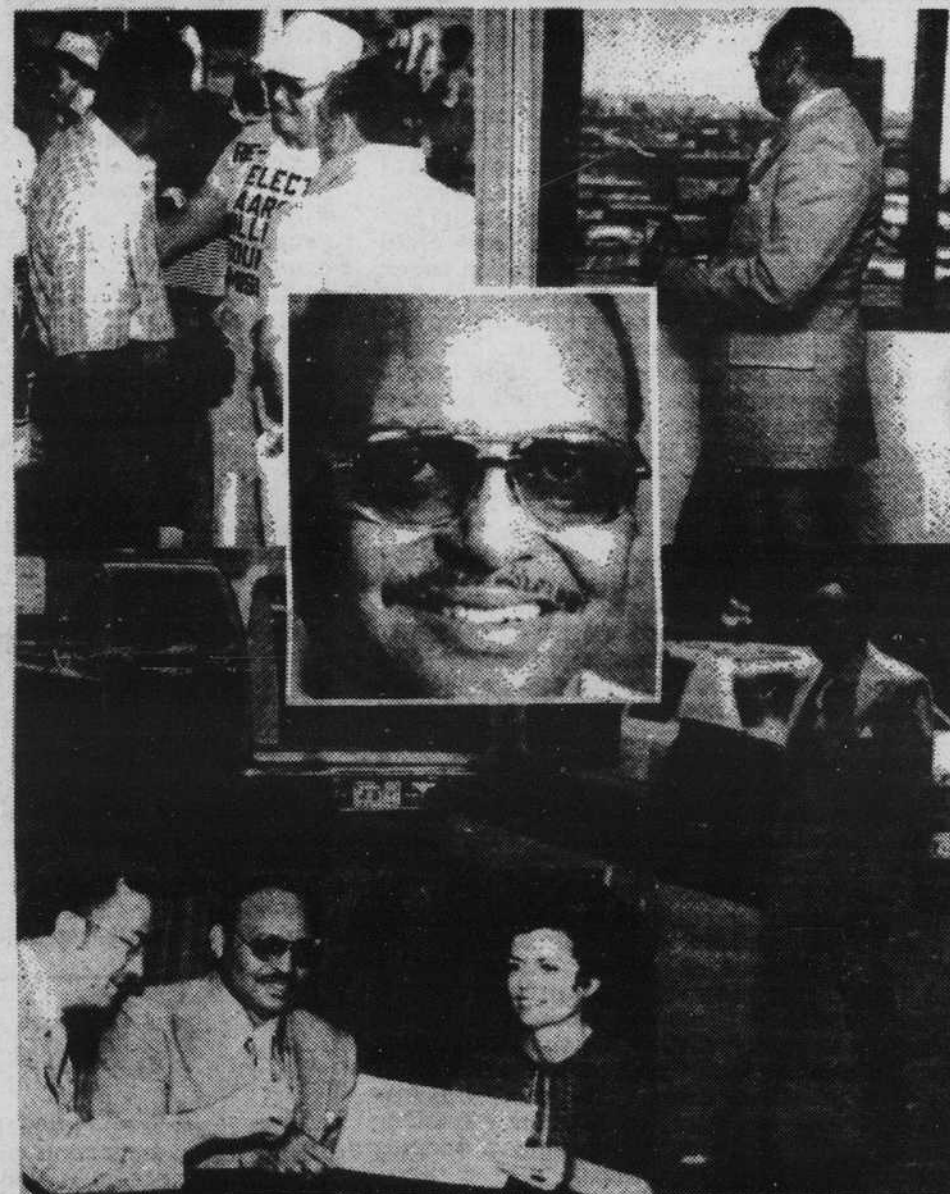
