

Black Vote Apathy VS. Vote Power

You don't count-you are nothing if you don't register and vote. The politican considers you nothing because you did not vote for him and you did not vote against him. Latest reports indicate 45,00 blacks in Las Vegas, which translates into 9,000 families (5 per family), or at least 18,000 potential votes.

Most elections are won or lost on a few percentage points. If two thirds of our local eligible centage points. If two thirds of our local eligible people were registered and voted we could control the elections. This would provide us with the greatest power we could assert. The politicians would really seek out our vote and we could demand and get some real worthwhile concessions in Las Vegas. In 1948 blacks nationally controlled 16 of the then 48 states. Harry Truman was belabored by the Southern Dixiecrats to abandon blacks on equal representation and civil rights. I was awake all night entation and civil rights. I was awake all night listening to the roll call and over 900 of the 1,300 voted with him for civil rights. He was acutely aware of the black vote power. When the election came, the Chicago Tribune declared Tom Dewey the winner and new president.
Not so. Truman went to bed early that election
night. I stayed awake all night while Truman
slept soundly and the next morning when the
count was completed Truman was still president.

When John Kennedy ran against Nixon in 1960 Kennedy won by roughly 1%. The winner could not be announced until two days later after California and Illinois and I ornia and Illinois results were determined. In ornia and Illinois results were determined. In 1968 Nixon won by less than 1% over Humphrey. President Johnson dallied around so long before releasing Humphrey to run that Humphrey's chances were very slim. Humphrey who is a master campaigner was so loyal that he would not breakaway and run before Johnson announced his non-candidacy and yet history and records show that Humphrey closed the gap so fast that he would have won if he had had only two more weeks and the country would have been spared weeks and the country would have been spared the Nixon-Ford nightmare. Since blacks are traditionally Democrats, Humphrey would have won if blacks had not adopted their apathy. Black votes could have changed this last eight year's history. I hope we don't blow it again. Register and vote. It is not too late!
