Judge Tom O'Donnell, on a motion filed by Reid, released Dunn on his own recognizance. Dunn had been sentenced to serve 60 days in jail by Judge Mullen. In releasing Dunn, Judge O'Donnell overruled the decision handed down by Mullen. A new hearing is scheduled for late September.

It is still not clear why Mullen had Rev. Dunn jailed. Dunn's case had been appealed to District Court - where Mullen has no jurisdiction.

In filing his motion to release Dunn, Atty. Reid claimed that the 60 day jail sentence imposed by Mullen was too severe for that type of case. Judge O'Donnell agreed. The city attorney's office had requested that bail be set for Dunn, but Judge O'Donnell refused to set bail, and instead released the Black activist.

Attorney Harry Reid is one of the best lawyers Blacks or poor people have to fight for their cause. Reid is not known to sell his clients down the river.

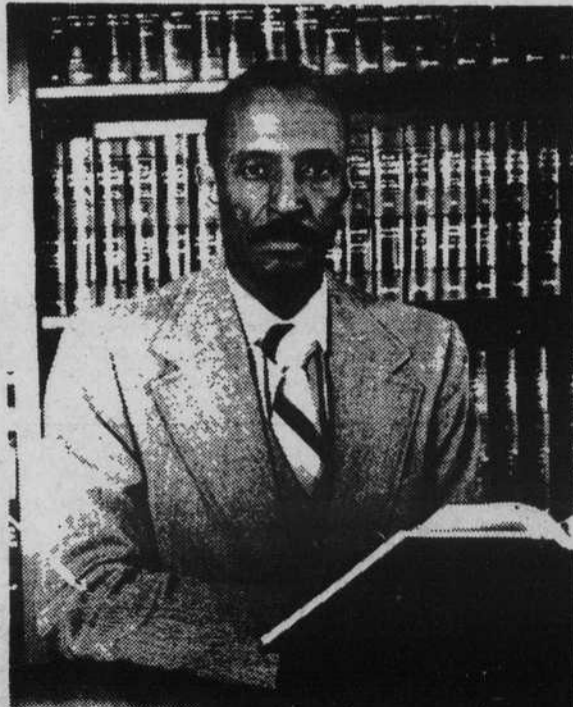

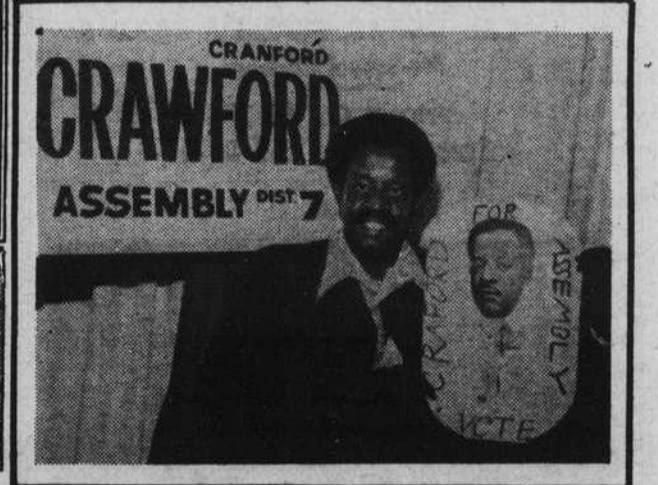
