
## Credibility - Who Has It?


After reading your column in the Las Vegas Voice dated August 19, 1976, I can see you did not check your facts!

have certain goals in their outline, job placement as well as follow-up and counseling.

I have no idea how long you have been in the Las Vegas area, we did have a skill center that taught a cooking program, however, due to CETA coming in and taking over all manpower programs it was closed (check CETA out, it's not working for anyone)

fight over.

In the last year the Black and Spanish communities have been trying to get organized to build a sound front to join hands against Whitey, so far white Supremacy has always managed to keep us apart or fighting. If you continue to to write such articles you too are helping pull us down.


of the people."
