Interpol Illegally In State

A recent study of the Nevada Revised Statutes by the National Commission on Law Enforcement and Social Justice (NCLE) has revealed that Interpol, the private French police group, may be operating illegally in the state.

According to Michael O'Brien, Southwest director for the NCLE, there is documented proof that Interpol has been in communication with government agencies in the Las Vegas area, and a strong indication that the cooperation with inter-pol is widespread in governmental and private organizations in Nevada.

Breakfast & Lunch For Students

Elementary students will get pizza, sliced peaches, applesauce cake and milk the first day of classes, according to Len Fredrick, Director of Food Services for the Clark County School District.

Junior and senior high students will have their choice of 15 "combos," including a new low-cholesterol pizza made with low-fat cheese and vegetable protein "sausage," plus a full a la carte menu. All elementary school lunches and secondary school combos provide one-third of a student's daily nutritional requirements as set by the U.S. Department of Agriculture.

Breakfasts at all levels will start September 8, the second full day of classes. In the elementary schools, students will receive a reinforced breakfast roll, fruit or orange juice, and milk.

Older students may have the same or their choice of two others plates, one featuring scrambled eggs and bacon on a hot roll and the other ham and cheese on a hot roll. All three secondary breakfasts also feature juice and milk, and all breakfasts meet federal guidelines for one-third of the daily nutritional requirement for the student.

Lunch will cost elementary students 50¢, while junior and senior high youngsters will pay from 50¢ to 75¢, depending on the plate they pick. Breakfast is 25¢ at the elementary school and from 25¢ to 35¢ at the secondary level, depending on which plate is chosen.

For students who qualify, both breakfast and lunch will be available free or at a reduced price of 10¢ for breakfast or 20¢ for lunch. Qualification is based on total family size and gross family income. Children from a family of four persons, for example, qualify for free meals if total family income is below \$595.00 per month and for reduced price meals with a family income up to \$926.00 per month.
