

Michael Homes is a victim of weird brand of justice by any standard. The world he lives in is one of senseless killing and violence. I have personally heard police officers refer to a killing on the West Side as "another West Side misdemeanor." I have also been told by officers, that it does little good to take weapons away from lawless gun toters, because they'll have another the next day. My suggestion was then to keep taking the other weapons they come up with. I have also heard officers remark that they are glad when summer comes because it is then

more difficult for the hoods to conceal their weapons. Summarily it is not uncommon, not only on the West Side but the East, North and South Side for people to carry weapons. The robberies and assults we read about almost daily are not being committed with sling shots or pellet guns. Unlike most of the lawless gun toters, Michael

Unlike most of the lawless gun toters, Michael Homes is 21 years of age. He has worked on the same job since he was 18. He has never been arrested before for any violation. He was arrested though on August 24, 1976, for having a weapon in the auto. He appeared before Judge Robert E. Mullen on September 7, 1976 and was found guilty and sentenced to a \$500.00 fine and 6 months in jail - the absolute maximum under the law.

Michael Holmes comes from a respectiable, taxpaying family and is quite a respectable taxpayer himself, Certainly it is unlawful to carry a weapon without a permit. In retrospect, I am sure Michael realizes that, but his more serious moments he'll say "Oh Lord why only me."

Under the Federal Civil Rights Act of 1964 equal employment opportunities are guaranteed to all, regardless of race, sex, or national origin. It's been 12 years since this law was passed and five years since the Federal government made an agreement, called a consent decree, with the strip hotels, supposedly forcing the Strip to offer equal employment opportunities to all.
