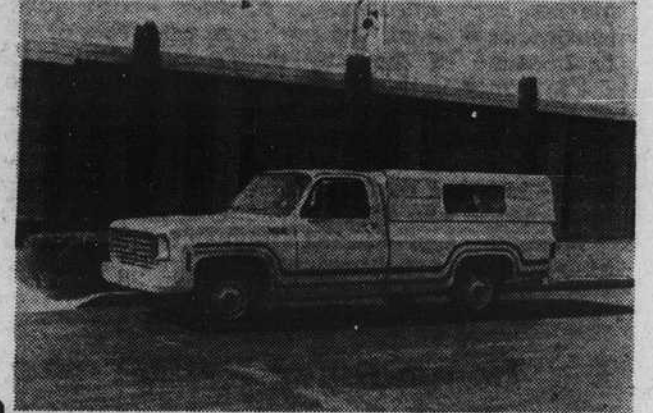

POLL SHOWS

DUNN LEADING IN

ASSEMBLY DISTRICT 6

According to a political poll taken this past week, Rev. Albert Dunn is now leading the incumbent, Rev. Marion Bennett, in the race for Assembly in District 6. Democratic Party activists taking the poll believe that Dunn's forceful campaign for economic development of West Las Vegas has gained him the edge needed to unseat Bennett.

Bennett has based his campaign on his experience in the Legislature and his chairmanship of the Assembly Health and Welfare Committee. His critics point out that in the four years that Bennett has been Chairman of Health and Welfare, welfare in Nevada has become much worse - with massive cutbacks in the Medicaid programs and thousands of needy Nevadans denied welfare assistance.

Dunn asserts, "We don't need welfare - we need economic development." He explains community economic development as meaning that "money earned by our community should stay here - deposited in our banks, spent in our businesses and for our services."

Dunn has been advocating economic development of West Las Vegas for several years. Within the past year he has become more outspoken in his advocacy, and his actions have forced government officials and business leaders to work together with the Black community to begin the economic development of West Las Vegas.
