A single individual attempting to enforce his or her employment rights is faced with a bewildering complexity of bureaucratic red tape. Employment law suits can take over five years and cost hundreds of thousands of dollars. The courts offer an uncertain remedy for the individual and the Federal government has shown that it's effect is certain - a whitewash!

JET believes that unity will provide the power base to confront the lage corporate employers on equal terms. The organizational meeting was held at the Westside Library and the faces were mostly Black with a scattering of Chicanos, Latinos and white women, but the real call those that together women and minorities - all those excluded from the white male positions of power - make up a new majority. United, organized, and with the force of law as fuel, JET is taking off.

At it's second meeting on August 30, JET chose it's name and formed a temporary governing council composed of Black, Chicanos, Latinos, and women. Committees were formed to collect discrimination complaints and to prepare a

membership drive.


