I am white, 42 years of age, a resident here for almost five years. I would like you to listen to me and maybe even help me - and this could even be at the expense of a black. I'm not going to try to don angels' wings here and claim I haven't had at times some inner feelings of resentment toward certain blacks; I have

Recently I was fired from the Clark County School District on trumped-up charges and a black man was responsible. He is Herschel Wil-liams formerly principal at Jo Mackey sixth grade center and now principal at one of the new

In my first year of teaching (1973-74) I was hired by a Mr. Smith to teach math during the summer. He visited the class often and at the end of the summer wrote a letter describing my efforts and recommending me for "rehire." In my second year of teaching (1974-75) I was interviewed by a black woman who took Mr. Smith's ceived a letter from this woman (carolyn Reedom) explaining that their program wasn't sufficiently large enough - and my application was rejected.

Now the school district says the "quote" system was not the reason. Mr. Silvestri claimed that the black woman who was hired without any previous experience in the CCSD summer school program was hired because, as he put it, they just like to give everybody who qualifies a chance.

Are our children guinea pigs. A teacher is put in charge, does an excellent job (as I did), and then is removed because they want to give

someone else a chance to prove himself. I have this in writing from Charles Silvestri. And remember the quota system is not involved here by their own admission.

My record now has been so filled and distorted that I would find it impossible to secure a job even as dog catcher in this community. Mr. Williams lied under oath to protect a fellow black. He falsified a document and if I could afford even a contigency small fee I would go after this man Williams.

I feel that there has been a gross miscarriage justice and that you might be interested in


THE APPOINTMENT of Lemuel T. Smith as di-

BLACK PRESS-AN OPPORTUNITY

Recent reports indicate a constantly increas-ing circulation of Black newspapers and magazines. Blacks are realizing that the only real communication between Blacks is the Black Press. For over 30 years I have been associated with it. In 1941 I started "Racial News Agency" in Columbus, Ohio which had less Blacks than Las Vegas. I made \$75.00 for a day and a half's work. I was the distributor for most of the top work. I was the distributor for most of the top Black papers: Pittsburg Courier - Chicago De-fender - Ohio State News - Afro American -

New York's Amsterdam News, etc.
An enterpriseing Black could now probably double or triple my earnings and make a full An enterpriseing Black could now probably double or triple my earnings and make a full time business. Most Blacks are not aware of the many magazines by Blacks but with a little promotion sales should produce a health income. Black Enterprise, Sepia, Essence are but a few of the many latest ones which have grown in stature and are successful. The Black Press also provides the greatest opportunity for Black embryo reporters, writers and photographers, writers like Woy Wilkins, Wendell Smith, Chester Washington, Vernon Jordan, Billy Rowe got their training and experience with the Black Press and went on to become syndicated columnists with large incomes. Chester Washington who was an editor for the Pittsburg Courier years ago now owns the biggest chain of papers in the Los Angeles Community - The Wave Newspapers - with a reported 100,000 copies weekly. Blacks and whites advertise in the Wave Ppaers regigiously and provide jobs for many Blacks.

Our own paper-The Las Vegas Voice-could become a tremendous success if only the Black businessmen here would each buy a small \$10 or \$15 ad weekly on a continous basis. Their business wold grow.

Most Blacks are not aware of the many services and merchants in our area. Black earnings are very great and their necessary purchases could greatly enhance our area and produce much of the economic development we are looking for.
