We have been told and everybody should be a-ware of the establishment of "The Westside Development Commission." Since this commission's inception, nothing has been developed people are still playing games, namely Mayor Bill Baire and the Rev. Marion Bennett.

Earlier this year, a proposal was submitted and accepted, upon investigation, in the amount of \$96,000.00 for the purpose of setting up an office with a small staff for community development, inclusive of a new face lift of the com-munity -- High risk loans -- enabling residents to bring their homes up to grandends. to bring their homes up to standards, code, etc. (we all know that along with community development should come economic development.)

All was assumed to be well, until the acting chairman, Rev. Bennett, met secretly with Bruce Sprawling, regarding his proposal, which in-cluded the same entitles mentioned above -- for the same purpose but only with less money -\$28,000.00. The difference was the proposal earlier was authoried and submitted by the black community and the later proposal was submitted, but taken out of the writings of the first proposal, by a white man. And, of course, the amount of money.

Now -- it seems as if when the money comes, which is expected in December -- this black community will be again at the disposal of white supremcy -- why? Because we have chosen leaders that made secret deals and have secret meetings to align their personal pockets for their own benefit rather than complete representation of the entire black community.

The Board of Directors were not notified,

have not, as of yet, seen the later proposal, and have absolutely no idea of how the \$28,000.00 will be spent. And I, for one -- being on the Board of Directors would like to have a voice and be notified when policy decisions are being made. For after all, I am a Board member and would like to have been able to voice my opinion

as to relative needs for the black community.

I have been left out -- and because it was not officially approved by the Board of Directors

-- I submit that the later proposal is invalid for implementation.

I would also like for the acting chairman, Rev. Bennett, to please respond via an open Board meeting as that we may act on these kinds of proposals in an official manner. Hoping that he will respond soon, for if he does not respond, then this whole community will know that he is indeed making deals behind closed doors with the white man to continually control the destiny of the black community.

It is time to stop blaming our elected representatives and band together for the common good. For it takes all of
