BLACK EX-VETERAN NAMED

KANSAS CITY, MO. - Robert L. Wooton, a career civil servant, has been named employment opportunity specialist for veterans with the U.S. Labor Department's headquarters here.

In his new post with the department's Employment Standards Administration (ESA), Wooton, who is black, will administer the employment provisions of the Vietnam Era Veterans Readjustment Act. of 1974.

The Act applies to employers who have U.S. Government contracts for goods, services, or construction, greater than \$10,000. They must take affirmative action to see that Vietnam Era veterans and disabled veterans get equal opportunity for jobs, and they must list virtually all job openings with the State Job Service. Under another law, veterans are given priority consideration by the Job Service.

Wooton, 40, is a native of Baxter Springs, Kan. and was graduated from Pittsburg State College.

A veteran of Marine Corps and Navy Service, Wooton has been in the Labor Department here since May 1971.
