**American Jewish Committee
responds to NAACP plight**

NEW YORK -- The American Jewish Committee has responded to the plight of its long-time civil rights ally, the National Association for the Advancement of Colored People, by supplying more than \$20,000 in gifts and loans toward the bond the NAACP must post in Mississippi to contest a court decision there.

The NAACP last August was ordered to pay more than \$1.2 million in damages to businessmen in Mississippi for injuries they claim to have sustained when the organization conducted an anti-discrimination boycott there beginning in 1966. In order to appeal the decision, the NAACP must post a bond of more than \$1.6 million.

In response to an appeal for help from Roy Wilkins, NAACP Executive Director, the Board Chairman, Margaret Bush Wilson, the AJC Board Governors this week voted a grant of \$1,000 and a loan of \$15,000 underwritten by individual members.

"The NAACP and the AJC have been engaged for many years in the struggle to achieve basic human rights and dignity for all minority groups in our society. In coming to the aid of our friends in their time of distress, we are living up to our fundamental principle of seeking improved human relations for all people everywhere."

Founded in 1906, the AJC is this country's pioneer human relations organization. It combats bigotry, protects the civil and religious rights of Jews at home and abroad, and seeks improved human relations for all people everywhere.

**"Shameful and
Unresponsive"**

WASHINGTON -- The Internal Revenue Service Service has a "shameful and unresponsive" record in failing to cooperate with The National Commission on U.S. Policy Toward Gambling, Nevada Senator Howard Cannon told the Senate recently.

Cannon said that excellent cooperation had been received from various state agencies of the Executive Department, and authorities in foreign countries.

"I regret to report that IRS has been unresponsive to specific questions and even to invitations to appear and assist the Commission in its search for facts," the Senator said.

The Commission has been in the process of making its final report after a three-year study of gambling in the United States. Earlier Cannon had criticized the Service at a Nevada field hearing for failure to heed an invitation to testify.

"Only this week high officials of the Canadian government, The United Kingdom, and the government of the Bahamas appeared before our Committee for a two-day discussion of tax policies," Cannon said, but added that IRS Commissioner Alexander chose to ignore a personal invitation and failed to even send a representative.

As a result the Commission formally apologized to the visiting dignitaries. The Nevada Senator reported difficulty in explaining Alexander's inability to make the trip from a few blocks away from Capitol Hill where his office is located while the visitors traveled many thousands of miles to accommodate the United States Congress.

"It is easy for me to see why the IRS is in such low repute among our citizens. One wonders whether the word "Service" should be deleted from the "Internal Revenue Service" to more accurately portray its role. I fear the IRS bureaucracy considers itself an independent branch of government."

Are sun-powered heating and cooling systems really the way of the future?

**SOUTHERN JUSTICE
THREATENS NAACP**

A Mississippi judge has ordered the National Association for the Advancement of Colored People to pay 12 white merchants over \$1.2 million because of a boycott the NAACP led against their stores in 1966. The boycott was seeking employment for black people.

The 1966 boycott, protesting job discrimination and other racial abuse in the town of Port Gibson, Mississippi was called by the judge an "unlawful conspiracy." The NAACP calls the judge's decision a "legal lynching."

We need your help to fight this injustice.

Mississippi law requires that we post a bond or cash in excess of \$1.6 million just to appeal the judge's decision. This money must be raised within the next ten days. If we do not appeal—because we are unable to post the bond—then the NAACP must pay \$1.2 million it does not have. If this happens, we're out of business.
