Jet Meeting Scheduled

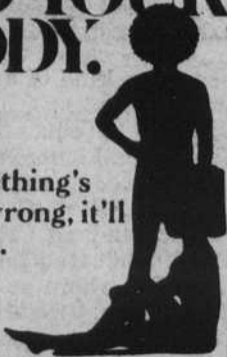

must be firmly opposed to the spreading of cancer in the neophyte computer industry. This technological field is one of the few areas in which blacks with skills to sell have not been regulated to the bottom of the ladder by nature of color.

Congressional representatives of black constituents must call a halt to the Bell bill. The phone company has done nothing in its past to endear it with blacks, women or other minorities. Ma Bell does not warrant the support of poor people to monopolize another industry.
