

Since the VOICE cannot get cooperation out of but a select few community leaders, then I will appear in Carson City personally to bring


back the news to the community. Mr. Bailey says that he pays more money in salaries than any other establishment in West Las Vegas. That is not true.


The reason I am pointing all this out to you is because I will not like to see them (you) make another mistake like they (you) did in the

BREAKING UP BIG OIL

The Congressional Black Caucus has a chance to cultivate employment opportunities for blacks. By supporting the bill for divestiture of the 18 big oil companies of this nation, congress can control these almost incomprehensible white job giants.

Number one alone, Exxon Corporation with sales last year of \$44.8 billion is even bigger than General Motors. Exxon employs few blacks and none anywhere near their top management or board of directors.

or board of directors. Exxon which is practically lily-white employs about 137,000 people and had profits equal to each worker of over \$18,000. Most of the blacks who hold white collar jobs are clerks. This is a sick symbol of the oil industry. This largest oil company alone had world-

wide crude oil and natural gas liquids produc-tion in 1975 of 3,684,000 barrels per day, equal to about 20 percent of the daily needs of the en-

to about 20 percent of the daily needs of the en-tire country. The reason big oil deserves to be divested is its callous disregard for the rights of blacks and other poor people in America. Affirmative action has been a farce for these fat cats. The oil industry lags 33 percent behind other American businesses in the hiring and promo-tion of blacks. Thomas D. Duchesneau of the University of Maine, author of the 1975 Ford Foundation study, "Competition in the United States Energy Industry," says although the in-dustry's market structure looks competitive, the conduct of the industry shows an element of conduct of the industry shows an element of monopoly practice.

monopoly practice. In a competitive market with over capacity, prices should fall, the says. This was not the case in the 1960's. While world oil prices were falling sharply, U.S. prices were moving up. It's poor people, black and white, who pay for these monopoly practices by big oil. Gasoline prices are again on the rise.
