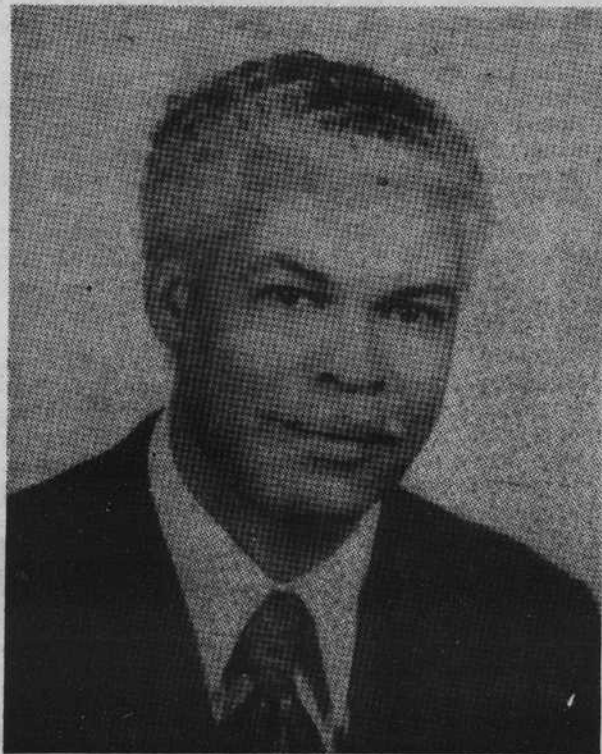


# Robert Reid Running Again

Attorney Robert Reid, former Justice of the Peace in Clark County, who is running once again for the Office of Justice of the Peace, today commented, "Clark County District Attorney, George Holt, like many other prosecutors across the country, blames Judges for the fact that many criminal defendants and convicted lawbreakers are quickly back on the streets to perpetrate more crimes against the citizens of our County." Continued Reid, "One of the major reasons for this breakdown in our System of Criminal Justice is, in reality, the practice of District Attorneys who engage extensively in plea bargaining, 'the negotiated pleas.'"

Mr. Reid went on to explain, "Persons accused of numerous violent crimes and potentially violent crimes such as murder, rape, robbery, burglary, and the sale of narcotics and dangerous drugs, are permitted to plead guilty to one or two charges, sometimes reduced charges, in exchange for the dismissal of three, five or more similar crimes."



Accused Reid, "This practice effects the time (if any), that a convicted criminal will spend in prison! In this wholesale 'bargain basement' type negotiated plea, the District Attorney sometimes recommends that criminals be given probation, or a minimal sentence. The 'revolving door' begins in the Office of the District Attorney, who is little more than a 'bargaining agent' for criminals. Using this practice of plea bargaining 'the negotiated plea,' the District Attorney usurps the function and authority of the Judge, the Jury, and the Probation and Parole Departments.

There is no statutory authority under Nevada law for the District Attorney to negotiate and bargain with criminals for the dismissal of public charges, explained Reid. Statutes (NRS 16q. 120) provides that every public offense be prosecuted. George Holt is the Public Prosecutor for Clark County; District Attorney Holt has no one to blame but himself for 'the presence of habitual criminals on the streets of Clark County. Reid continues, "He told the voters during his campaign two years ago that he was opposed to plea bargaining."

# Bernice Moten Endorses Jimmy Gay

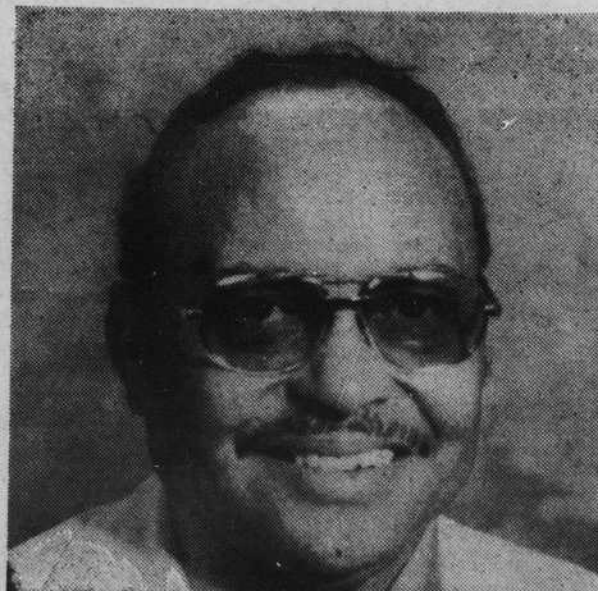
