

Batjer to Succeed Gunderson

In accordance with the vada Supreme Court. evada Constitution, The Nevada Consti-Nevada Constitution, Cameron Batjer, of Carson City, has been selected to succeed E. M. "Al" Gunderson as Chief Justice of the Ne-

tution provides that the senior justice in commission shall be chief justice. On the first Monday of January, 1977 Justice Gunderson's

present term will expire, and he will then be issued a new commission for a new sixyear term. Gunderson currently is running unopposed for re-election. At that point in time,

Justices Batjer and David Zenoff will hold the senior commissions on the court. The Nevada Constitution further provides that "incase the commission of any two or more of said Justices shall bear the same date, they shall determine by lot, who shall be Chief Justice."

At its business meeting this week, Chief Justice Gunderson placed two slips of paper, bearing the names of Justices Batjer and Zenoff, in a silver cup. Justice Gunderson then sum-moned to the court's conference room the Supreme Court's Clerk, Robert Davenport, who was instructed to withdraw one slip of paper. That slip bore Justice Batjer's name.
