"THE GENETIC CHANCE"

If genetic counseling had been available to Queen Victoria, the present Queen of England would never have been born: neither would the present King Juan of Spain, nor would Alexel, heir to the Russian throne. Europe would have had a very different history.

Queen Victoria was a carrier of hemophilia, a genetic disorder which prevents the victim's

genetic disorder which prevents the victim's blood from clotting. In the most severe cases even normal movement can promote painful, sometimes crippling, internal bleeding into arm or leg joints. Only male descendants of female carriers suffer from the disease, and the chance are even that if the child is male, he will be

a hemophiliac.
In "The Genetic Chance," on Nova, Wednesday, November 17 at 8 p.m., scientists explore the medical advances that are bringing these questions to increasing numbers of parents, and raising the important moral and ethical issues that accompany such advances. Modern techniques of analyzing fluids surrounding an unborn child have made it possible to determine the sex of the fetus. If it is male, parents can then be faced with an agonizing decision; should they terminate the pregnancy with an even chance of losing a perfectly normal boy, or should they go ahead with the same even chance that the boy will suffer from a possibly crippling disease? The decision is complicated by the fact that the treatment of hemophiliac boys has improved significantly in recent years and may continue treatment

MORE ON DIRTY SALLY'S

Dirty Sally's Discotheque, located on the "Strip" in Las Vegqs, has been found by the Commission to have engaged in discriminatory admission practices toward Blacks and other minority group members. Despite a Cease and Desist Order issued by NERC following public hearings in October and November, 1975 it has been alleged that the discotheque, which is owned by Las Vegas businessman Rainer Gund, has continued its discriminatory practices. In the face of Dirty Sallys' continued violation of the Cease and Desist Order, Commission Chairman Robert Archie wrote to Clark County Liquor and Gaming Board Chairman Jack Petitti re-Gaming Board Chairman Jack Petitti requesting the proper procedure to seed revoca-tions of its liquor license. Archie also asked that the Commission must show as cause" to make a revocation request.

Petitti contacted the Clark County District Attorney's Office and related the following in-formation to the Commission:

"If Dirty Sally's has been convicted of a mis-demeanor under the Nevada Public Accommodations Act (NRS 651.080) and if said misdeameanor involves moral turpitude, then such evidence could be submitted to the Board as

grounds for a revocation of license.

"The procedure the Civil Rights Commission (sic) should follow is set out in Clark County Code 8.20.600 - 8.20.660. It must file a verified compalint charging Dirty Sally's within a year of an act which is cause for suspension, with the County Commission. The District Attorney then determines the legal sufficiency of the complaint, and if sufficient, the Licensing Board shall issue a citation to Dirty Sally's directing it to show cause why the license should not be revoked. The Board fixes a time and

place for hearing at which time evidence shall be presented and a determination of the merits

rendered. "There have not been cases where liquor li-censes have been revoked for cause. Certificates of noncompliance have been issued with notice that unless corrections are made, the license would be revoked, but the licensee has always complied within the time limit established."

Since the public hearings in the fall of 1975, the Commission has received eleven (11) additional compalints of discrimination based on race or color. in fact or by assocation, against Gund's Dirty Sally's Discotheque. Five (5) of the complaints were by out-of-town visitors to Vegas.

The complaints filed aginst Dirty Sally's and the establishment's apparent continuance of its illegal discriminatory practices are of particular interest to NERC, because it is situations such as this that the Commission feels underscore its need to be greated expenses to the proposed expenses. score its need to be granted strong statutory

In addition to the findings of 'probably cause'
by NERC field investigators and the decision
by Hearings Officer Earle White and the Commission itself that Dirty Sally's has discriminated against Blacks, the establishment has
been 'off-limits' to personnel serving in the
Armed Forces of the United States since June,
1975.

Attorneys for Gund have filed a Petition for Judicial Review in an attempt to have the decision of the Hearing Officer and the Commission declared null and void, and the Cease and Desist Order vacated. The Attorney General's office has filed an answer to that petition for the Commission, asking that it be dismissed. The case is now pending.
