**WONDER ALBUM
BREAKS RECORD**

Stevie Wonder's "Songs In The Key Of Life" added yet another milestone to its record-breaking precedence by topping the best-selling album chart in Billboard trade magazine for the fifth consecutive week.

It marks the longest sustained period that an album which entered the charts at number one has remained in that position. The old record of three weeks was held by European star, Elton John.



Wonder, who became the first American to have an album enter the charts at number one, is sitting comfortably in that position on the album charts of all three music trade magazines, Billboard, Cash Box, and Record World.

It is Wonder's own personal best for weeks in the number one position, but to break the all-time record for a number one album, Wonder's "Songs In The Key Of Life" would have to remain in its current position for a total of over 14 weeks.

The current record for consecutive weeks as number one on the best selling album charts in all three of all three music trade publications, is held by rock star Peter Frampton.
