BUSINESS IN THE BLACK By Charles E. Belle ECONOMIC OUTLOOK

Billions of dollars will be-pass blacks for at least the first half of this year. The new administration's proposals are not likely to be felt until the fall. Such is the structure of the American economy. After a pause and pitiful attempt to recover in late 1976, the nation's economy needs some stimulus to pep it up. The most encouraging factor in the present state of the economy is that the United States has left the recession of 1974 and 1975 alone with the conditions that helped bring it about in the background.

Although inflation will continue to rise, it will be at ess alarming rate than recently. Unemployment is likely to decline for whites. The national economy is basically strong if you are not either poor, young, and/ or black. With corporate profits expected to increase 14 percent on top of 1976's 25 percent, nousing construction may climb with falling interest rate and new car sales likely to rise as the rich get richer, 1977 will see a resumption of the nation's economic recovery.

There is hope that the black masses might benefit from big government spending on job creating and training programs. Unfortunately these programs take months if not years to produce results in the depression hit black camps of our nation.

Unemployment should average seven percent for the full year 1977. This is 50 percent too high for blacks to see any positive change in their economic position. Disposable personal income will rise for those people who are working. Business investment, the major ingredient missing during 1976, is expected to grow moderately during 1977. Corporate profits will continue to increase by \$12 billion after taxes in 1977.

This bulge in big business pockets is likely to put the stock market higher in 1977. The combination of a respite in the inflation rate and the liquidity effect of easier money has lowered interest rates; big business conditions are likely to steadily improve month by

It is difficult to envision stock prices not rising vigorously and broadly in such an environment. Specifically the combination of reduced neerest rates (continued on page 3)
