EDITOR'S NOTE: Following are representative questions answered daily by VA counselors. Full information is available at any VA office.

2 - I was honorable discharged in 1970 and have had problems in obtaining employment. Can I return to school under the GI Bill to obtain my high school diploma and then continue training to improve my employment possibilities?

A — Yes and the time you spend in school toward your high school diploma will not be charged against your educational entitlement under the GI Bill.

Q - I am rated 40 per cent disabled for VA compensation. Can I receive additional benefits for my wife?

A — Additional benefits for dependents of veterans with service-connected conditions are limited to those rated 50 per cent or more disabled.

Q — Why is my VA pension allowance reduced when I receive an increase in Social Security benefits?

A - VA pension is payable to wartime veterans with permanent and total disabilities, not resulting from service. The monthly stipend is based on the amount of annual income a pensioner receives from other sources. Social Security payments and other retirement benefits, less a 10 per cent exclusion allowed by law, are included in the annual income.



Our addiction to quick fix programs not only mislead us but provided the enemies of social reform with endless ammunition. Granted, the Administration of President Lyndon B. Johnson launched the most ambitious set of federal programs designed to uplift folks out of misery and disadvantaged status in the history of the United States

However, when one looks at the amount of money spent and the limited time alloted these program efforts, it becomes quite clear what really happened. In retrospect, many of us who were caught up in the rhetoric of a "War on Poverty" feel that it would have been more accurate to describe that uplife effort as at best, a skirmish.

The word coming out of Washington these days indicates that more money will be available for human services in the area of mental health, services to the handicapped, family planning along with programs designed to produce more jobs for disadvantaged unemployed young people.

Indeed this is good news, but we cannot again afford to be taken in again romantically by impressive titles of


