Ruby Says

On Wednesday, February 23rd, Operation Life in conjunction with the Department of Labor, Women's Division, hosted a workshop for Low-Income Women. The purpose of the workshop was to give these women a forum to express their frustrations about welfare and being poor and just what they could do to find employment. Three women from the Department of Labor were present to hear and take back to Washington issues that low-income women care about.

The Department of Labor had requested that the workshop be limited in number so an active discussion could take place. Thirty-one women, all ages and colors, participated. The major complaints of women were 1) that welfare is a poor substitution for jobs and that women want to work, that transportation presented serious probleins and that adequate low cost chold care was needed. Many women expressed the problems they saw with job training and education -- once they were trained, employers said they had no actual experience to back up the training and would not hire them.

We would like to thank all the resource participants that took time from their busy schedule to come to the workshop and give their ideas on what could happen to improve the delivery of service: for low-income women and how a coal-ition could be worked with various women's organizations and employment related programs

to develop more jobs for women. Some of the participants in the workshop repre-senting agencies included Clark County Social Services, Clark County Juvenile Court Services, the WIN Program, HOME Counseling, the Fran-ciscan Center, Nevada State Personnel, the Governor's office, the North Las Vegas Police Department, FOCUS Youth Services, Nevada Department, FOCUS Youth Services, Nevada Women's Conference, Equal Rights Commission, Nevada State Welfare, NAACP, Nevada NOW Organization, PPPT, the Internal Revenue Ser-vice, the University of Nevada, the Women's Democratic Club, the Economic Opportunity Board, and Clark County Legal Services. My deepest appreciation to those who attended and help d to make the workshop a success. I hope that we continue to meet and discuss methods that we continue to meet and discuss methods and strategies to be used to end the welfare state and give us a working economy.

Early Screening is still being operated by the Jackson Street Clinic at Operation Life. Free medical check-ups to people who have medicaid cards and are under 21 years of age. It's unfor-tunate, but the facts of life that if you want early screening for yourself or your child, you must first get a SAMI 25 form from your social worker at State Welfare. Call them today and tell them you want to have early screening.

Again, Operation Life gives its thanks to the Economic Opportunity Board members. They voted to table a request that EOB do early screen-ing. EOB's staff's rationale was that it went along with their WIC program . . . But not one of their WIC participants would be eligible for the EOB WIC program which serves only people NOT on Medicaid. It is a Federal law that EPSDT be given only to Medicaid children and it is state regulations that the EOB WIC program serve only non Medicaid children. EOB Staff did not explain
