Our country is going through a crime wave such as we have never seen before. The cause? Many blame our ever-growing drug problem for at least half of the muggings, pursesnatching, shoplifting, burglaries and the senseless, cold-blooded murders. With our estimated one million drug addicts each stealing an average of \$100 per day to support the habit it is costing our country \$36 billion a year plus court and prison costs. In addition, per reports, we are adding 100,000 new addicts a year, mostly young people recruited at our high schools and even grammar schools. At the present growth rate our crime costs will

double in less than 10 years.

Is there a solution? Yes, there is: the British drug program. Some 15 years ago Britain wrote off curing addicts and concentrated on prevent-ing the spread of addiction. How? BY TAKING THE PROFIT OUT OF THE DRUG TRAFFIC! Britain registers her addicts and then supplies each with his daily needs FREE, this at less than \$10 per day each for both drug and administration costs. Their program has been working successfully for 15 years with the number of their addicts down to 3500, most of them holding jobs. Recent visitors to Britain confirm their streets are safe day and night.

I believe if enough concerned citizens would write their Congressmen urging that the program be tried out here we could soon get it into open tion, thereby saving our country some \$34 billion a year in crime costs and, preventing tens of thou-sands of youngsters a year from becoming addicts. We have everything to gain and nothing to lose by

trying it out.

To help get the program under way I, with the help of friends, am sending this letter to the editors of 250 newspapers and 30 magazines across the country hoping many will print it and that many the country hoping many will print it and that many people will respond by writing their Congressmen. To save you some time and effort I suggest that you cut this letter out, past it on a sheet of paper with your comments, then have photocopies made sending them to President Carter, your Congressmen and a few others. With a few thousand letters going into Washington we can get the program in-to operation here and hopefully make our streets safe again.

MARCH 4, 1977 was the first anniversary of the brutal and unmerciful murder of brother Darryl J. Taylor by officers Weaver and Sommers of the Las Vegas Metropolitian Police Department. Brother Darryl was critically wounded nine times from a moving police vehicle as he fled in fear of his life after becoming the victim of an unprovked police search, allegedly for possesion of a firearm and disturbing the peace. The incident began when the manager of a local snack bar telephoned police saying a man was acting strange in front of the Humdinger Restaurant. Eyewitnesses at the scene reported that nothing unusual occured to warrant police involvement in a discussion among community people involving God and life which were favorite topics that Darryl J. Taylor frequently dicussed with anyone who would listen. After pursuing Darryl J. Taylor for eight blocks by car as he fled on foot bewildered by the sudden appearance of several police cars, Darryl J. Taylor who had no prior history of violence fell lifeless from police bullets only six houses from his own. Neighbors and eyewitnesses heard no verbal warning to halt and many of them stated they too were trying to avoid the numerous police bullets which left bullet holes in many occupied homes on both sides of the street where the Clark County Grand Jury, which has no representation from the Black community failed to indict officers Jerry Weaver and Arthur Sommers when the county coroner's inquest found the officers guilty of gross criminal negligence and turned all evidence over for further investigation.
One year later justice has not been done and
DARRYL J. TAYLOR'S spirit cries out for justice but who will hear his plea to SAVE THE CHILDREN from these killers and others who are paid to serve and protect, not maim, kill or neglect. "We need Community Control of police now."
