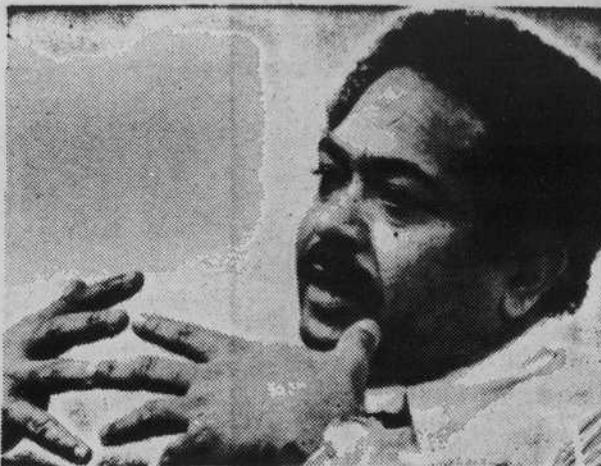


LT. GOVERNOR MERVYN DYMALLY

**NOTICE to BEN SCHMOUTEY**  
On April 26, members of Culinary Workers Union Local 226 will vote to elect a new secretary-treasurer to replace the late Al Bramlet.  
This election is classified as an "interim" election. As such it is NOT covered by provisions of the Landrum-Griffin Act (a Federal Labor Act) which would allow members to request and obtain federal supervision of any REGULAR union election.  
I formally request that a mutually acceptable impartial election committee be appointed to supervise procedures at both the nominating session and the election itself. This committee's work shall include but not be limited to the observation of nominating procedure, voting, and the counting of votes.  
A most desirable committee would be comprised of one Clark County Commissioner, one Las Vegas City Commissioner, one judge on the bench of any court serving Clark County, and one union member representing each qualified candidate.  
Under any circumstances such a committee would be helpful in avoiding any possible irregularities, but under the existing conditions such a committee is absolutely necessary to assure the conduct of this election be above any suspicion. The events leading up to this election as well as the current Federal investigation into operation of the union's pension fund must certainly be considered extraordinary circumstances.  
Should this request not be fulfilled, action will be taken—as prescribed by law—which will assure to all union members as well as the public full disclosure of the entire conduct of this election.  
I make this request because it is my legal right and responsibility to do so and also because it is the only way I know to protect the rights and interests of all members of local 226.
