It was Gunderson who stood at the side of attorney Charles Kellar when the Bar said "Kellar, we don't want you to practice law." While Mr. Gunderson and underdog Black Man Kellar stood side by side all the way to the Supreme Court, Gunderson was the lawyer for Kellar, and he won. MINING OUR BUSINESS

The American Mining Congress has been meeting since 1897 to maintain a minerals policy for America. Arab and other oil producing nations have forced America to review its entire energy needs. President Ford has responded with a Rockefeller sponsored \$100 billion spending project.

Blacks in some states can benefit in increased mining activities, while others can

Blacks in some states can benefit in increased mining activities, while others can profit if located in mining and power equipment manufacturing areas. In 1973 alone the combined ouput of mining, metal, mineral reclamation and energy industies was valued at over \$175 billion. Blacks should not allow these "wasting asset" industries to waste them in the coming world mineral demand explosion.

explosion. BLOCK DISCRIMINATION

The development of a mineral policy or more specifically an energy po icy must inlude social demands for racial progress, as well as, secular demands for profits. Government

as, secular demands for profits. Government contracts at the state and community level must be leveraged with federal proposals to block racially discriminatory developments.

The U.S. Bureau of Mines estimates coal to be 18 percent of the country's sources of energy consumption. They also estimate the equivalent of 600 billion barrels of oil shale rock development in several Western and Mid-Western States. The President expects to spend, with Congressional approval,

and Mid-Western States. The President expects to spend, with Congressional approval, over the next ten years about \$100 billion.

This includes large expenditures for both the mining an utilities industries. The electricity generation companies who use 26 percent of the nation's energy sources should be called on the carpet for their practices from the janitors room to the board room. Our energy situation is changing rapidly. The prime fuels such as petroleum and natural gas are no longe in abundance. The proposal by President Ford presents an opportunity for providing project independence all right enough — equal employment independence for Blacks.

Local Councilmen and the Black Congress-ional Caucus, which just recently held a big party in Washington, D.C., would do well to start sending this employment message to all who would be beneficiaries of the Pre-sident's, boondoggle.
