

BUSINESS IN THE BLACK

The strangle hold on this nation that the oil industries hold is revealed by some members of the oil's big six oil sisters. Mobil Oil, who recently cut off its \$50,000 yearly contribution to a journalist college for hiring an honest executive director, is among the group of 15 major oil companies suspected of overcharg-

ing consumers by billions of dollars.

The Federal Energy Administration will name a special investigator to look into the rip-off. A special team of auditors will check over the books of some of the nation's largest

oil refineries.

The agency intends to peek in on crude oil producers and resellers, such as those com-panies that buy oil from producers or imp-orters and sell it to refiners. The 15 largest refiners that will be under investigation include both Exxon Corp and Mobil Oil Corp, a subsidiary of Mobil Corp.

Mobil is the parent corporation of Mont-gomery Wards. While the FEA has been auditing thousands of oil industry concerns, it has not yet completed an audit of a major oil company in its almost three years of existence. The results of which dictate a divestiture bill to break the oil companies down to a workable size.

The seriouxness of this price fixing charge indicates an astronomical cost to the consumer. It is predicted that this country will be consuming over 18 million barrels of oil a day in the near future. The recent black-out in New York City highlights our dependence on mankind developed energy sources.

The current investigation is underway because it is believed that major oil refiners

cause it is believed that major oil refiners like Exxon and Mobil Oil have overcharged consumers billions of dollars. A Mobil Oil spokesman has replied to the charge that to the best of their knowledge, Mobil is in

compliance with the regulations.

This may not be a Richard Nixon statement, but it bares thorough investigation of the facts and the law. An oil divestiture bill would bring and the law. An oil divestiture bill would bring this kind of strain within the scope of standard auditing practices. It would help indicate early on when a company is beginning to overcharge consumers since regulators could more easily understand the complex oil industry.

One of the oil companies says it has made massive efforts to comply with the complex

and confusing and often contradictory FEA regulations. This is precisely the charge regulations. against big oil companies operations made

by poor people.

Write your Congressional Representative calling for an oil divestiture bill, so everybody can understand why oil prices in America are going up faster than in Saudi Arabia.
