For a kid who has never played football before in his life, his first outing and all during practice he has always managed to cross the goal line.



Marden Poque for New Facility

This reporter interviewed Edward Poque,

Warden of the new Prison facility at Jean, which is due to open January 3, 1978. The feelings are that the opening of the facility at Jean will releave some of the pressure at Carson City by taking 1/3 of the inmates from Carson City and transferring them to Jean. The transfer will take approxi-mately 4.5 mosths mately 4-5 months.

The first group to be transferred to Jean will be 25 inmates from the Clark County Jail, and 25 from Carson City, who are from the Las Vegas area. These men will do the final clean-up of the area, plant grass, clean cottages, etc. and generally get the area ready for the rest of the men. Then every 3-4 weeks another 50 will be transferred until a total of 450 men are housed at Jean.

of 450 men are housed at Jean. Jean is a facility for Young Adult Male Felony Offenders between the ages of 18-27, with an average of 2-3 years to serve. The Work Release Center on Highland Ave. will be phased out, and the Work Release program will be operated from the facility at Jean. At the present time there are approximately 15 men on Work Release out of the Highland Ave. office. After Jean is in full operation, they expect to have 25-30 on work release.

The rest of the men will work full shifts at jobs available to them. Some of the pos-sibilities are a detergent plant; a horticulture department; a light weight assembly for electronics or other plants; or a recycling plant for waste food and other material. Some of the men would work for the Forestry Service, or on Highway Construction.


Long time prison terms, men considered dangerous to other people, and hard core men would be placed in Carson City, with the pos-sibility of serving the last 2 years of their sentence at Jean.

Jean Hobby Shops would be open only during

leisure hours, and not be a full time operation as it is now, or rather as it was, in Carson City, due to the lack of work for the over-crowded facility.

Mr. Poque stated that he was contemplating hiring ex-offenders as Guards at Jean. He stated that the man would be hired on his ability to relate to the inmates, the length of time he/she had been out, and their work histroy. Just the fact that he/she was an ex-offender was not recommendation enough, but would be one of the considerations. The men at Jean will be living 25 to a

cottage, each living in a private room. Maybe this will alleviate some of the agonistic feelings among the inmates.
