After graduation, he served two years as a Regenald Hever Smith fellow, assigned to Community

Legal Services in New York City. Action In 1974, Gary was appointed to the staff of Nevada Attorney General Robert List, where he was the only Black on the staff. Gary was California state high school

wrestling champ. While in Carson City, he organized the Pee Wee wrestling program. Wrestling and law were both important to

Gary. At the time of his death, Gary was associated in law practice with Michael Hines, having been a Public Defender prior to that. He was a member of the state and federal bar associations in Nevada and California.

They will just kill me, or, give me more time.


So look what they've done to us, misguided men.

In an interview with Larry Childress and Peter Hahn of Smith's Food King, this reporter learned that the closing of the Smith's Food King Store in the Golden West Shopping Center was entirely for economic reasons.


Rent increase, utility increase, salary increase, and customer decrease combined to, make the closing feasible. The store in the Golden West Shopping

Center was between two other stores one Washington and Rancho, and the other

in Civic Center. The "Let's Go To The Races" sponsored by Smith's Food King brough more business into all the stores in the Greater Las Vegas area, but did not bring any response to the store in the Golden West Shopping Center. Special flyers, coupons, etc. were also un-successful in bringing people in. Larry Childress stated, "I don't know or

care how many businesses have moved out of the Golden West Shopping Center. The Smith's store was closed strictly for economic reasons."

Peter Hahn stated "The equipment is old, and the store really needed to be refurbished. It would have taken between \$200,000 and \$300,000 to do so, and the way the store was losing money, this just was not feasible.

Men and women of the Greater Las Vegas area were in an uproar about a rash of rapes, robbery, etc. that hit the area a couple of weeks ago.

Thursday night, September 22, Las Vegans were resting easier because 4 men were picked up and accused of four count of rape,

picked up and accused of 4 counts of rape, 4 counts of robbery, and 8 counts of the use of a weapon in the commission of a crime. Only 2 suspects were wanted, but 4 were

picked up. One of those picked up was Herman Simmons. On Monday, Herman took a lie detector test and was absolved of all charges. The only reason Herman was picked up was the fact that his car was used in the commission or the crimes. After his car was identified, the police arrested Herman, and upon his testimony, the other 3 men, John Whitmcre, Duane Whitmore, and Royal Wilcox. John Whitmore is out on \$250.00 bail, as his only connection with the crime was being in his brothers home at the time of the arrest. Herman was absolved of all crimes due to the results of the lie detector test.

Duane Whitmore is Herman's ex-brotherin-law, and had borrowed Herman's auto, saying he would return it in an hour. Six or seven hours later he returned the auto, using it in the commission of the crimes, along with Royal Wilcox.

Inreatening phone calls have been received by Herman's wife, and she would appreciate it if these calls stopped. Gary White, the attorney that was killed Saturday in an automobile accident, was Herman's attorney. On Friday, Gary saw Herman and told him he would see him Monday to accompany him to take the lie detector test. Due to the sudden demise of Gary, Tom Lea, Public Defender, took over

Gary, Tom Lea, Public Defender, took over and accompanied Herman. The VOICE just wants to remind every-one --- Herman was absolved of all implication in this crime.
