
hotel. Not only would you be aiding the Westside, but your overhead would more than

BUSINESS IN THE BLACK By: Charles E. Belle

The last time I was loose in Louisiana I was guffing down gumbo at Dookie Chase Restaurant in New Orleans. Hmmmmm-ain't that sumpin'. Now I hear a call from brother Sherman N. Copelin, project manager of Superdome Services, Inc. a minority service firm for the superdome, in

Copelin claims Hyatt Corporation, the hotel chain hailing from my state of California, wants to cut off black heads. Copelin has

wants to cut off black heads. Copelin has already begun legal proceedings to contest Hyatt's right to cancel Superdome Services and sever their black employees.

Hyatt Corporation operates a chain of 52 hotels (51 under the name Hyatt) in 23 states, as well as, 11 motels in some seven states. The equal employment opportunity practices of its 23,200 employees has not been challenged by Black Americans in the past.

Hyatt Corporation is hiding behind two black faces according to Copelin. These two are to replace the black owned firm which employed more than 3,000 people last

Rumors are that racism is running through this black rip-off in more ways than one. New Orleans for the first time has a black elected mayor. Superdome Services, Inc. is the reportedly only minority firm with a sizable state contract.

Hyatt Corporation which also runs gambling businesses in Lake Tahoe and Las Vegas, Nevada has even the federal government investigating the firm. The Hyatt Corporation, whose president recently assigned amid charges by the company's special counsel of financial improprieties, has been under a separate and much more extensive investigation by the Securities and Exchange Commission for the past year.

Jay Pritzker is the president and chairman of the Hyatt Corporation. The Pritzker family owns 34 percent of the hotel chain's common stock. While these charges are aside from the conflict caused Mr. Copelin and Superdome Services, Inc., it's clearly cause for concern when considering the sour source of an outfit boasting social responsibility while trying to cut blacks out of the profit picture.
