What shall we say then? Is the law sin? God forbid. Nay, I had not known sin, but the law: for I had not known lust, except

For I was alive without the law once: but when the commandment came, sin revived, and I died.

And the commandment, which was ordained to life, I found to be unto death.

For sin, taking occasion by the commandment, deceived me, and by it slew me.

Wherefore the law is holy, and the commandment holy, and just, and good.

Was then that which is good made death unto me? God forbid. But sin, that it might appear sin, working death in me by that which is good; that sin by the commandment might become exceeding sinful.

For we know that the law is spiritual: but I am carnal, sold under sin.

For that which I do I allow not: for what

would, that do I not; but what I hate, that do I.

If then I do that which I would not, I consent unto the law that it is good.

present with me; but how to perform that which is good I find not.

For the good that I would I do not; but the evil which I would not, that I do.

Temple Church of God In Christ, at 10-12 130th Street New York, New York.


