## **Job Placements**

A wide variety of jobs are available for Senior Citizens 55 years of age or older. Also available is a free job placement serv-ice for employers in the Clark County Area.

The Federal Government has recognized that there are many qualified Senior Citizens, with a wide variety of skills, who not only want to work but, during these times of ever increasing costs, need to work, in order to supplement

meager incomes.

Available through the U. S. Department of Labor are Federal funds administered, in part, under contract to the National Retired Teach-

ers Association (NRTA) and the American Association of Retired Persons (AARP).

Low income Senior Citizens, 55 years of age and older, are placed in jobs with public service and non-profit organizations. This service and non-profit organizations. This results in immediate supplemental income plus an opportunity to revitalize previous skills and to become familiar with the current-methods of "doing things". After brief, supervised, retraining periods of 90 to 180 days, these Senior Citizens are encouraged to seek self-supporting employment in the private sector of the economy. To assist them, other Senior Citizens, enrolled in the Program, function as job developers to work with those who might need assistance in getting back into the main stream. into the main stream.

The Program has been quite successful and proves that our Senior Citizens are not looking for "hand outs" but want to be self-supporting. for "hand outs" but want to be self-supporting. Employers, on the other hand, have welcomed the abilities and skills of our older citizens. They have found these Senior Citizens are often more reliable and steady workers who are proud and possess a work ethic that is a fundamental part of their basic character. Louis Whitley, longtime resident of the Las Vegas area, and twenty year member of Cul-inary Local #226, has filed his candicacy for the post of President of the Culinary Union Local #226. Louis and his beautiful wife, June, were interviewed in their home at 2508 Chambers, North Las Vegas, Nevada, surrounded by momentos reflecting a strong family life with their three children.

Commenting on his twenty years of employment at the Testsite, Louis stated that his original reason for seeking the presidency of the Culinary Union lies in the fact that over 50% of the membership is Black. However, Blacks have no policy-making authority. They have no representation at all at the policy-

making level.

"It is the old story of the beginning of the end of the Culinary Union as we know it today. Taxation (in the form of membership dues),

without representation is an abomination."

Asked about other points in his platform to gain member support, Louis continues, "Without stronger management, this union will not exist as a local labor power another five years. The Pension Plan is antiquated and requires a complete revision so that the needs of our growing membership can be met more adequately. The present plan requires years of continuous employment in the craft. Now, this is a ridiculous requirement, in that the nature of this employment often requires that employ-ment cannot be continuous. It requires that one bow to the pressure of 'seasonal' and some-times convention oriented work which is often sporadic -- not continuous in nature. I am sure that members are more than interested in the types of revisions which I would propose in the Pension Plan — revisions which would be more realistic in relating to real life circumstances of pre-retired culinary workers."

workers."

"Revisions are way past due," says Whitley,
"when we analyze the Health Plan. Members
learn too late of the inadequacy of our plan
once they really have to use it. Simple revisions in the plan could increase the benefit
to a reasonable level of adequacy for our
hundreds of members who have no choice but
to use this as their only coverage when health
problems strike in their family."

"Last of all, and perhaps one of the most
serious shortage, is the complete lack of a
Credit Union for our members. If our union
can lend hotels millions of dollars for projects which are fundable through other sources,
and don't directly help our members — surely we can lend the money and expertise needed

to set up a plan whereby our union members
can receive the benefits which are unique to
credit union membership."

"I know," continues Whitley, "that I represent the sentiments and that I am speaking
