NOTES TO THE FINANCIAL STATEMENTS

NOTE 1. ORGANIZATION POLICIES
The Greater Las Vegas Billy Graham Crusade has been organized under Nevada Law expressly for this crusade. It is entirely responsible for the subscription and expenditure of all crusade funds and is organizationally separate and completely apart from the Billy Graham Evangelistic Association.

Dr. Billy Graham receives no remuneration from this crusade. He is paid an annual salary by the Billy Graham Evangelistic Association with headquarters in Minneapolis, Minnesota. Salaries and expenses for other members of the Evangelistic Team are pro-rated to the time spent in the Las Vegas Area. Apart from this and some printed materials, the entire budget will be disbursed in this area.

NOTE 2. BASES OF ACCOUNTING
The activities of the Greater Las Vegas Billy Graham Crusade were accounted for on the cash basis reflecting actual cash receipts and disbursements, except for the accrual of accounts payable of \$2,400 at March 28, 1978, for which the Crusade had not been billed.

NOTE 3. ADVANCES Initial working capital was provided by two \$5,000 advances from the Billy Graham Evangelistic Association and the Michigan Billy Graham Crusade. The excess of receipts over disbursements will be applied against these advances which, as of March 28, 1978, were not refunded.
