- Q -- I used my home loan eligibility shortly after World War II and recently sold that home. Can I use my VA loan guar-anty again to buy another home now?
- A -- If your previous loan has been paid in full, you are eligible for another VA loan guaranty.
- Q -- Is there any kind of VA education or training available for veterans who have serious service-connected disabilities and whose termination dates have passed?
- Congress has eliminated termination dates under the VA vocational rehabilitation program for veterans with serious service-connected disability who need education or training to obtain suitable work. Under the VA vocational rehabilitation program, the VA pays for tuition and other training costs, and the vereran receives a monthly living allowance during training.
- Q -- I was disabled in WWII and the VA gave me \$1600 toward the pruchase of an automobile in 1949. Now that this allowance has been increased to \$3300, am I entitled to the difference on another
- A -- No. But the VA may assist in providing or maintaining adaptive equipment on your present or future cars. Adaptive equipment will not be provided a claimant for more than one conveyance at a time and for not more than three conveyances in a two-year period.

Education Is Power By Thomas E. Wilson

People are often ineffective readers because they fail to see the plan behind the writing. Instead, they think in terms of separate phrases and sentences. Failing to see the pattern of organization underlying the reading material, poor readers see only an endless parade of sentences of seeming equal importance. Without guidance from the organizational structure of the material, the reader cannot distinguish the important ideas from the mass of details. the important ideas from the mass of details. Thus, when the poor reader finishes a selection, he is left with the confused feeling that there was much that he lost in the jumble of sentences. In contrast, the effective reader knows that a knowledge of the organizational structure of a selection can help him to understand his reading better, to read more purposefully, to learn efficiently, and to rem-ember ideas and details.

An important technique to use in discerning organizational pattern is over-viewing, described in a precious column.

Another important technique is organizing reading involves the ability to grasp main ideas quickly from paragraphs. Every reading selection is composed of paragraphs, and each paragraph, with the occasional exception of certain structural units, presents an idea. Paragraphs, therefore, may be considered as units of thought. Quickly discerning the main point of each paragraph will enable one to read rapidly and still get the important ideas of the article. of the article.

In much of his reading, the reader does not really need the details - the main points points suffice. Yet, too often, people do not even notice the paragraph structure while reading. These ineffective readers fail to see the paragraph as a package of meaning containing an idea of main importance. The rest or qualifies that idea.

The main idea of a paragraph is most generally given in an explicit statement. This

statement, called the topic sentence, appears first of last in about 90% of all paragraphs.

Position is not a foolproof guide for finding the main thought of a paragraph. While the main idea is usually stated in one general sentence, it may be expressed in two or more sen-

tences or not explicitly stated at all.
One cannot mechanically choose a paragraph's main idea by position alone. Instead, graph's main idea by position alone. Instead, think of each paragraph as a package of meaning. The main part of the paragraph is what the paragraph is about. Determine this by asking yourself: What is the main subject, thing, person, or place dealt with; and what happens or is done?

Develop the technique of paragraph reading so that the paragraph is seen as a unit of meaning. Then automatically look for the main idea of each paragraph in order to distin-guish this main idea from the details which Understanding paragraph structure and the ability to grasp the main ideas contribute greatly to accuracy of comprehension. As one reads, he may better understand the material in terms of main ideas and supporting details - that is, he outlines the material mentally as he reads.
