Justice E. M. "Al" Gunderson recently filed a dissent in a case because he stated the Nevada Supreme Court had come "close to the ultimate compromise," in its majority decision.

In effect, Justice Gunderson was complaining that his fellow justices were deciding cases by virtue of one judge writing an opinion without the other judges looking at the briefs written by either side or even looking at the record on appeal, and not having oral arguments.


The Las Vegas Voice applauds Justice Gunderson for his courageous stand in speak-ing out against further judicial compromise.

Justice Gunderson is well-known to the readers of the Las Vegas Voice. He is the same man that, while a private attorney, worked to have Moon Mullen elected to the municipal court. He was, in effect, his cam-paign manager. Moon Mullen is not the only black person that Gunderson has stood shoulder to shoulder with for causes to better Nevada. Justice Gunderson also is responsible for Charles Kellar's being able to have a lic-ense to practice law. He was the only person that Mr. Kellar could find to represent him when the entire bar association was trying to take Mr. Kellar's license to practice away from him.

One of the justices who is more famous for being drunk than for writing legal opin-ions stated that Justice Gunderson took too long in filing his dissent.
