## NAACP

If Sunday's "Community Rally" sponsored by the Las Vegas Chapter of the NAACP is an indication, organizational efforts to rally the Black Community and its supporters have proven an unqualified success.

Dr. James McMillan, NAACP President, today expressed gratification at the results of the Chapter's week-long program of activities which culminated with Sunday afternoon's Program at Rev. I. W. Wilson's True Love Baptist Church.

Love Baptist Church. Principal Speaker at Sunday's Rally was Mrs. Tarea Hall Pittman, special consultant to the Rev. Benjamin Hooks, NAACP National Executive Director. Mrs. Pittman was sent by the West Coast Regional office to Las Vegas in support of local NAACP action in the wake of the County Commission's denial of an NAACP lawsuit to force redistricting of the County, enabling opportunity for Black representation on the County Commission.

Among the announcements made by President McMillan prior to the introduction of Mrs. Pittman and one that was of particular interest to NAACP members was that the NAACP had retained Attorney Eugenia Pintos Ohrenschall to represent the organization in its upcoming suit against the County Commission.

A vigorous pitch for memberships and contributions led by M.C. Jessie D. Scott, Jimmy Gay, Woodrow Wilson and Bishop E.N. Webb swelled the coffers of the local branch by more than \$5,000.00 with a yet untotaled number of pledges ranging from \$25.00 to \$100.00. A complete list of donors and Life Membership pledges will be published in the next issue of the VOICE. Sunday's contribution included a \$2500.00 donation from Alpha Rho Chapter of Gamma Phi Delta Sorority. It was announced by Past President Lubertha Johnson that Alpha Rho has donated a total of \$5000.00 to the NAACP in the past year.

Mrs. Pittman gave a brief but informative history of the National and Local NAACP's involvement and accomplishments in the entire spectrum of civil and human rights. In delineating the distinguished record of the NAACP legal staff, her announcement that NAACP attorneys had gone to the Supreme Court 38 times with a record of 36 victories gave obvious satisfaction and pride to those present. Mrs. Pittman also noted that the County Ordinance allegedly forbidding demonstration in the County of Clark will be hand carried by her to the Regional attorneys for study and determination of its constitutionality.

constitutionality. Affording the audience equal gratification was a report from members of the Strategy Committee appointed by Dr. McMillan to explore options available to the NAACP in pursuit of its unswerving determination to achieve fair representation and equal opportunity for Blacks in Clark County and the State of Nevada.

Bob Bailey, who is co-chairing the Voter Registration Committee with Marjorie Elliott, explained the various steps to be employed to ensure a successful massive voter registration drive. In the interest of time, Political Action Chairperson tabled that committee's report for the near future. Rev. Albert Dunn, Demonstration Committee Chairman, announced that a decision was agreed upon by the over-all Reapportionment Strategy Committee to submit the following recommendation for action:

- A request for the resignation of County Commissioner Sam Bowler creating a vacancy that the Governor will be called upon to fill by appointment of a Black.
  Re-evaluation of the Consent Decree signed
- Re-evaluation of the Consent Decree signed in the wake of the U.S. Justice Department's investigation of employment practices and that a further investigation be initiated of unjust employment terminations of Blacks with goal of reinstating those so terminated.
- 3. A law suit instituted against the County

Commission to redress arrant discrimination inherent in the Commissioners gerrymandering the County's electoral district.

- 4. An invitation be extended to the Governor, representatives of the Nevada Hotel Resort Association, County Commissioners to meet with President McMillian and his committee to negotiate NAACP proposals.
- 5. In the event these demands are not met within 30 days, the Demonstration Committee make recommendations for action to the Executive Board of the NAACP.

Mrs. Sarann Knight, Vice-President, NAACP Membership & Life Membership Chairperson expressed herself as extremely pleased with the results of the two-day Membership Campaign Kick-Off and her great appreciation of all those who participated in efforts for its success. She noted that Jessie D. Scott, NAACP Executive Committee member and Executive Director of the Nevada Equal Rights Commission, has the wholehearted gratitude of the NAACP Membership Committee for his unstinting efforts toward making the NAACP Membership Kick-Off Campaign the success that it was.
