Workshop

If you are going to attend college in the fall, you should plan to attend the fifth annual "Pre-College Preparation Workshop," Aug. 7-11 at the University of Nevada, Las Vegas.

Co-sponsored by the Division of Continuing Education and the University College at UNLV, the program will concentrate on writing skills, development and speed reading, effective study skills and counseling to prepare for career development.

Participants may attend one of three four-hour sessions of the workshop starting either at 10 a.m., 1 p.m. or 5:15 p.m.

Instruction will be provided by Dr. Robert Glennen, vice president of educational services; Dr. Joseph McCullough, associate professor of English; and Dr. Austin Flynn, dean of education at DePaul University, Chicago.

Registration should be received by May 22. Contact the Division of Continuing Education at UNLV for information.

EARLY REGISTRATION

A four-month early registration period for fall semester classes is in progress at the University of Nevada, Las Vegas.

The long pre-registration schedule is intended to eliminate registration lines by allowing students to complete their enrollment for classes at their convenience. Students may pre-register any weekday between now and Aug. 11.

"There is absolutely no need for anyone to stand in a long registration line," said Muriel Parks, dean of admissions and records. "We'll be distributing packets and accepting fee payments in Frazier Hall every weekday from nine to five, and people can enroll for classes at their leisure."

Students may complete registration by first picking up their registration packets in the Frazier Hall corridor. Next, they collect their class cards in the department offices, then return to Frazier Hall to pay their fees.

Those taking advantage of the pre-registration schedule will not have to participate in the regular registration session Aug. 31 in the Moyer Student Union Building.

Fall instruction begins on Sept. 5 with a late registration period continuing through Sept. 12.

Parks said admitted students who did not attend classes during spring semester must file a new application for registration by July 15. These students will be permitted to pre-register two weeks after they receive a verification that their registration materials are being processed.

Newly-admitted students may pre-register two weeks after receipt of the Certificate of Admission, she said. Those who have not been previously admitted must fill out an application form, pay a small fee and request transcripts from any previous high school or college attended.

Persons wishing to take six credit hours or fewer this fall are not required to go through the admissions process but may enter as special students.

Pre-registration for two five-week summer sessions is also under way at UNLV. Starting dates for the sessions are June 12 and July 17.

Insurance Redlining

The American Jewish Congress called today for "tough laws and tough enforcement" to stop redlining by insurance companies in ghetto and "transitional" areas.

David Levy, chairman of the insurance redlining subcommittee of the American Jewish Congress Metropolitan Council, testified before the New York State Assembly Committee on Insurance hearing on redlining, which he termed "a major cause of neighborhood deterioration and urban blight in the city."

"The insurance industry has drastically reduced the amount of fire and other forms of property insurance it is writing in certain geographic areas of New York," Mr. Levy said. He added:

"Many companies are now refusing to write any insurance regardless of either the condition of the property, the claim-free loss experience or the reliability of the insured."

"This situation is by no means limited to the so-called 'devastated' areas of the city; it is becoming increasingly common throughout Brooklyn, the Bronx and Manhattan."

"The minority communities in New York have been particularly hard-hit. Black and Hispanic brokers frequently have access only to the FAIR plan, the Assigned-Risk or Federal crime insurance for their clients, who are thus relegated to the status of second-class citizens."

"This situation presents a considerable financial impediment to many hardworking, upwardly mobile Black and Hispanic families who seek to buy homes or property in red-lined communities."

The American Jewish Congress spokesman proposed these five steps to end insurance redlining in New York State:

"1. Full and public disclosure by all insurance companies and by the FAIR plan, on an annual basis by zip code area, of the policies written, of rejections, non-renewals and cancellations."

"2. Legislation should be enacted prohibiting insurance companies from canceling or refusing to renew existing policies because of age or location of the property, or the age, sex, race, ancestry or occupation of the policy-holder."

"3. Insurance companies should be prohibited from terminating agency contracts or brokerage accounts because of unfavorable loss ratios."

"4. Fire insurance pool (FAIR plan) rates must be based not solely on the loss experience within the plan but on the statewide experience in the equivalent voluntary market. Many poor people have suffered serious financial hardship because of the escalation of FAIR plan rates."

"5. The FAIR plan must be permitted to write homeowners insurance at rates which take the experience of the statewide voluntary market into account. This will alleviate a pernicious form of discrimination against minority homeowners."

Mr. Levy concluded: "A neighborhood whose residents cannot obtain insurance is a neighborhood without hope. Insurance redlining accelerates neighborhood deterioration and urban blight. Tough laws and tough enforcement are needed promptly to prohibit redlining and similar practices which cast a pall upon our city and state."

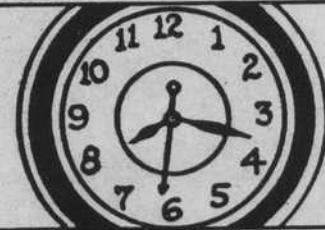
