Illegal Advertising

Political candidates are reminded of federal and state restrictions concerning outdoor signing and asked to keep their advertising legal by the State Highway Department. Political signs along Nevada's primary and Interstate highways are subject to the same content as other outdoor advertisement accordtrols as other outdoor advertisement, accord-

ing to State Highway Engineer Joe Souza.

Candidate signs within State right of way are illegal and will be removed immediately by the highway forces. Those posted or erectby the highway forces. Those posted or erected otherwise along primary or Interstate
routes must have permits from the Highway
Department, be located in appropriately zoned
areas, and meet other state regulations.
Owners of any sign found in violation will be
cited by letter, and the illegally posted sign
removed at the owner's expense.

During May and June, all candidates on the
Secretary of States list will be mailed copies
of current outdoor advertising regulations, and

of current outdoor advertising regulations, and the necessary permit information to register their signs.
