What hurts the eye'in and ear'in is that more and more we are being typed with every passing reel which has begun to hurt the image of our real life. The film weighs heavy on the minds of folks, and the race which comes out more often as marauders, bent comes out more often as marauders, bent on doing in the elderly, fill the young with death causing drugs and force young girls into a life of prositution, are looked upon as thus in real life. The constant terror that was "Seige," the TV flick about the plight of the elderly in the concrete jungles of any big city. In this dramatic special ne comer Dorian Harewood, whom I understand, in private life is the soul of gentility, portrayed vate life is the soul of gentility, portrayed a gang boss of urban Black and Puerto Rican guerillas. He did a hellva job spewing his wrath on Sylvia Sidney in her fortress apt. The depressing realism, as he came to grips with Martin Balsam must have caused some senior citizens to attempt to lock out bitter off screen memories. It was great drama and we do not castigate the producers because the heavy was black, but tell them that unless he runs the gamut of the total acting scale, little old white ladies will see me in the street and call a cop.

Plunder and pimpery are not the met-hodology of the black American. Nor is rackhodology of the black American. Nor is rack-eteering the "Godfatherly" way of all Italians. And surely a Jew should not always be typed as the pushcart vendor selling cheap on the lower Eastside. Nor should the Irish be de-picted constantly spending their ditch-digging wages over the bar of the corner saloon. Germans are not all Nazis shouting "Achtung" in a "Holocaust" concentration camp. To carry these absurdities to comical conclusions would mean that all Scotchmen should port-ray penny-pinchers and that WASPS must always be painted as tan shoes wearing, thin-lipped, imperious, forever looking down on ethnic fellows who don't sing, "Long Live The Queen!"

Let's get off it fellows, variety is the spice of life. Just as blacks were not the eyerollin, shufflin characters of the "Way Down Dixie," "Halleluja" era of Stepin Fetchit, Willie Best, and the like, nor are they the hi flying pimps and hustlers of the present day teevee had guys and gals. Law inforcers day teevee bad guys and gals. Law inforcers are wasting enough blacks without, "To Kill A Cop," which starred Lou Gossett, Jr., hitting the network to add fear to the daily ryme and reason to blowup another. Though it's just a reel drama it colors the minds of real folks and offimes causes death dealing of real folks and oftimes causes death dealing very live, through not living action.

If I seem to be a one-man anti-defamation league, it's because many of you who eye this corner and the boob-tube are charter members with no soap box to yell from. One of the kind of flicks there should be more off is "Law Man Without a Gun." This NBC made for TV film is heavy and depicts the life of the first black man to be elected sheriff of an Alabama County. 

However, for some teachers there is con-stant frustration because of harassment by supervisors to achieve unrealistic goals. The teachers find themselves eyeball deep in paper work, receiving constant criticism and have little time to teach children. God help the teacher who tries to be creative in the classroom. He soon learns that being creative is not rewarding, if he plans to continue work in the school district.

As a trustee, I find two attitudes among our board members concerning problems.
