The NAACP general membership meeting will be held Sunday, June 11, at 4:00 p.m. in the Economic Opportunity Board's Day Care Center, 1818 Balzar Avenue. Delegates will be chosen for the NAACP National Convention in Portland, Oregon, July 2-7.

Dr. W.C. Patton, NAACP National Director of Voter Registration and Voter Education will arrive in Las Vegas June 15 to participate in the local branch's Voter Registration Drive.

NAACP President, Dr. James B. McMillan announced the National office is extremely interested in the local political scene and will offer substantive support to the Las Vegas Chapter's Registration and Get-Out-The Vote campaigns.

Bob Bailey, Chairman of the local Chapter's Voter Registration Campaign said he has furnished Dr. Patton with all requested information pertinent to total population in the City of Las Vegas and the County of Clark as well as percentages of Blacks registered against total eligible Black voters in the County.

I am a newcomer to the Westside area. When I came, about six months ago, I had trouble finding a place to live that I could afford. Therefore I read your paper, in hopes that someone would advertise a house for rent. I became very interested in your editiorial and began to attend community meetings, hoping to get involved. However, I became very confused; I attended several community meetings and NAACP meetings assuming that all community people were for improve-ment of the Black area for better housing, jobs etc. I found two different groups that were into what they said is economic development. Well, let me tell you, I came from Los Angeles and was there during the riots and I heard about all the federal monies that was supposed to have been put in the Watts area. I started out attending meetings and trying to get involved in the upgrading of the area and people. Believe me, I have witnessed some of the same problems this community is having now and I saw what could have been good destroyed by the so-called leaders. Watts had an elected official such as the Black Senator that did not agree with anything whether it was for the betterment of the people or not, and saw several groups fighting each other until both were destroyed and the city took over; the Welfare Economic office in the old hotel is a goodi example of what you can expect for the future growth of the black people. People such as Reverend Albert Dunn that preaches that he started economic development and more welfare for the Black people, if he did all those things then why is he tearing down something he put together? For him to make remarks that he makes, he is really confused; that is not the way for economic development for the people. He and the Sen-ator did a good job with the welfare program, but it is time for all Black people to work together and not fall into the trap the people of Watts did.

The people in the community should not let this happen any longer, the people should ask why and not sit back until it is to late. I intend to let my voice be heard and heard loud and clear, I do not intend to sit any longer, and wait for the leaders to do something about this; what I have learned the
