> He joined the Clark County School District in 1960 as the result of a nationwide search.



he has served on the Clark County Economic Opportunity Board, and currently holds the position of president. Because of his efforts, the E.O.B. has enjoyed its strongest period of development.


Other positions Dr. Perkins has held with the school district include Assistant to the Superintendent and Assistant Superintendent for Administrative Services, his current post.
