BUSINESS IN THE BLACK

People on low or fixed incomes use a higher percent of their paychecks for utility bills than middle and upper income groups. The average black family median income is almost 40 percent lower than the average white family.

This means a monthly electric and gas bill of \$10 for each family is actually 30-40 percent more of an expense for Black America. An increase in the nation's fuel bill will become a disproportionate increase in the cost of living for the black community.

Blacks and other poor people should benefit from low cost sources of energy for elect-ricity. Each source of fossil fuel energy for electricity, oil, coal, natural gas and nuclear needs to be examined for its cost as well as its environmental effects. Even the already developed oil and gas fields of South Texas have been known to be high in uranium

The use of nationally located uranium for nuclear power plants can prevent increasing dependency on high cost imported petroleum which will result in increased utility bills for blacks and other poor people.

Most of the uranium mined today will be used to produce electricity. The process begins with the uranium oxide of yellow cake, which is shipped to be processed by the federal government. The government plants convert it into plutonium enriched metallic

These are loaded into tubes, the tubes are tied into bundles which become the radio active cores at generating plants. These cores provide the heat that causes water to boil into steam. The steam turns that run the generators that produce the electricity.

It's important to note the role and responsibility of the U. S. government in get-ting this source of fuel from a hole to a house. Even the problem of what to do with the uranium after the process, incorrectly called the waste, is a responsibility of the U. S. government.
