The purpose of the meeting is to obtain citizen input on West Las Vegas Aesthetic Enhancement, a project currently under development by the City of Las Vegas Department of Recreation and Leisure Activities, Cultural and Community Affairs Branch.

The goal of the project is to provide works of art in public places in the West Las Vegas community. Project funding is provided through the Community Development Block Grant program.

Public guidance is requested on such matters as potential sites and identification of possible project artists.

Reconstruction consisting of pavement, traffic control devices, rail-road crossing devices, drainage facilities, curb, gutter, and walk to provide six travel lanes between Las Vegas Blvd. and Polaris Avenue, and four travel lanes between Polaris Avenue and Valley View Blvd.

WASHINGTON AVENUE - MAIN STREET/LAS VEGAS BLVD.

New construction and reconstruction consisting of right-of-way acquisition, pavement, traffic control devices, drainage facilities, curb, gutter and walk to provide four travel lanes.

Reading Course

The second section of a developmental reading course for junior high school students will begin July 17 at the University of Nevada, Las Vegas.

The class, which is designed for students who need to improve their reading skills, is sponsored by the Division of Continuing Education and the Reading Center and Clinic at UNLV.

Instructor Robin Baumbach is currently associated with the reading center at UNLV. She has taught reading and the Language arts at the junior high school level and has taught speedreading.

Vocabulary and comprehension, adjustment of reading rates and the development of reading purposes are some of the topics that will be explored. Baumbach said that this is not a remedial reading program.

Annual Meeting

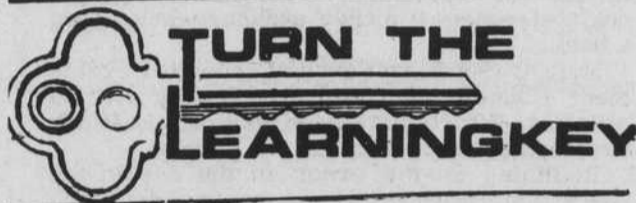
The National Black Child Development Institute will hold its 1978 annual meeting at Hotel Inter-Continental Miami, in Miami, October 25 to October 28.

Some 300 delegates from around the nation are expected to attend.

"Black Children Just Keep On Growing" is the theme of the conference, which according to Mrs. Maurine McKinley, associate director, will "examine the very critical issues that impact on the development of Black children and youth."

Discussions topics on the agenda for the four-day conference include the youth employment act; model programs for Black children; the juvenile justice system; family day care -- implications for Black children and families, and general child welfare, child development, public policy and research projects.

The Black Child Development Institute Inc., headquartered in Washington D.C., Kenneth Haskins, president, and Evelyn K. Moore, executive director, was founded in 1970 by the Black Women's Community Development Foundation to provide a vehicle on the national level that would meet developmental needs of Black children.

of the Black-Americans. Neither side has ever bothered to discuss the causes of the Blacks inadequacies. Whatever the undesirable traits of the Black might be, the blame falls squarely upon the conscience of the ruling Whites who, themselves, created the problem which now threatens the whole scene of domestic peace as well as potential.

Let Las Vegas show the way for the USA. We need feasible planning and intelligent application of the plans.

We suggest that the City Commissioners, in conjunction with the County Commissioners, put their heads and hearts into such a planning program. The time is now! Adequate plans will not be born by spontaneous creation. Men must make the plans and men must make them work.
