The Loyola University Law School graduate said that although "plea bargaining is a way of life in prosecution work" it should only be made as a last resort, and even the, "the man at the top---the District Attorney himself---should personally review every case where it is suggested."

In addition to an extensive background as a prosecutor, Miller worked in the Los Angeles Sheriff's Office during the period he attended law school, and was later an assistant to the Administrative Chief of the Las Vegas Metropolitan Police Force.

The longtime Las Vegas resident said that if elected he would abolish the second grand jury created by George Holt "because Justice Court has virtually no backlog of cases, and can easily handle the load."

"And the court system is without a doubt a fairer and better forum for Justice, Miller said, "because the defendant, his attorney, as well as the prosecutor are all present."

"If the case is good, then the prosecutor shouldn't be afraid to bring it to a judge instead of presenting a one-sided plea to the grand jury, for an indictment that may not stand up in court," he added.

Miller said that he also believed the District Attorney's office should place "greater emphasis on actually prosecuting cases."

"The investigators in the District Attorney's office are there to assist in prosecution work instead of apprehending criminals. That's the job of the Police Department, and they are more than capable of doing the job," Miller said.

An active member of the YMCA, the Big Brothers of Nevada and the American Cancer Society, Miller resides with his wife, Sandy and their two children, Ross and Corrine.
