
State Directors of the List for Governor



Dr. Kenny Guinn

Robert List today named Assembly woman Sue Wagner and Dr. Kenny Guinn state directors of the List for Governor campaign.

Mrs. Wagner resides in Reno and presents the 25th Assembly District. Dr. Guinn of Las Vegas is administrative vice president of Nevada Savings and Loan Association.

"I believe these two individuals reflect the tone of my candicacy," Attorney General List said. "Both are active, concerned citizens who truly care about the future of this great state of ours."

In making the announcement, List said Mrs. Wagner and Dr. Guinn will take active roles in the campaign. "I did not want figureheads, but individuals who want to be involved and assist in setting the course of my campaign," the Republican candidate for governor said.

List and Assembly woman Wagner have worked together on a number of legislative matters in the past four years, including their successful effort to strengthen child abuse laws in Nevada. The two officials also have supported various legislation such as Ethics in Government Law, the Equal Rights Amendment, and increased senior citizens benefits.

Dr. Guinn worked closely with the Attorney General as Superintendent of Clark County Schools, as well as with List in a number of civic and charitable organization such as Easter Seal and American Red Cross. The two also have been active in the Southern Nevada Drug Abuse Council and the Nevada State Vocational-Technical Education Council.

Assembly woman Wagner is in her second term as a member of the Nevada Assembly and presently is seeking re-election. She has served on the Judiciary and Legislative Functions and Elections committees. Mrs. Wagner was the first woman to ever serve on the Legislative Commission.

Earlier this year, Mrs. Wagner was selected to be one of six young political leaders in the nation to participate in a U.S. Department of State study tour of Mexico.

Mrs. Wagner is married to Dr. Peter Wagner, an associate research professor at the Desert Research Institute. They have two children.

Research Institute. They have two children. Dr. Guinn, who grew up in Exeter, Calif. where List also lived as a child, was superintendent of Clark County School District until June 30 of this year. He resigned that post to take his present position with Nevada Savings and Loan. Dr. Guinn had been an administrator in the Clark County school system since 1964.

He also has lectured at the university level, as well as taught physical education, English and mathematics in California schools prior to moving to Las Vegas.

Dr. Guinn has been named Jaycee "Young Man of the Year," public administrator of the year for the American society of Public Administration and received the Phi Delta Kappa Educational Leadership Award.

He is active in a number of professional and civic organizations, including the United Way of Southern Nevada, Pop Warner Football program, and White House Conference on Children and Youth.

EOB WIC Program Expands

The Economic Opportunity Board of Clark County's WIC Program (Women, Infants and Children) is open for enrollment of low-income pregnanant and breast feeding women, infants, and children up to 5 years of age.

Eligibility is determined by income and nutritional risk of the client. Preselected supplemental foods for the expectant mother include eggs, milk, cheese, cereal and juices. Foods for new born infants include, iron fortified formula, and soy base formula for those infants allergic to milk, infant cereal, and juices. The voucher/check received by the client may be cashed at designated stores in the area.

J. David Hoggard, Executive Director stated "he was happy to announce to the community the new expanded WIC services for Clark County residents". Mrs. Esther Bell, Health Services Administrator stated "Many residents of Clark County may be unaware of the expansion of the WIC services offered by this agency's three clinics, she added all eligible clients could benefit greatly from this program.
