Fifth Year Block Grant

Richard B. Blue director of funds coordination for the City of Las Vegas presented to Mayor William H. Briare and the City Commissioners recommendations from the Block Grant Citizen participation review committee, programs to be included in the city's fifth Year Community Development Block Grant Program, on Wednesday, January 3, 1979 in the Commission Chambers.

A total of forty-fiveproposals from throughout the city were presented to the department of funds coordination for funding consideration for the 1979 Block Grant Funding year.

The forty-five proposals, representing funding requests exceeding \$4,000,000 were submitted by city departments and community agencies this year. However, less than \$2,000,000 is available under the fifty year Block Grant year.

The January 3rd meeting was a public hearing during which time citizens were afforded an opportunity to present their views regarding the programs recommended by the citizens participation review committee.

The next and final public hearing is scheduled for Wednesday January 10, 1979, at 9:00 A.M. in the Commissioner Chambers of City Hall, 400 E. Stewart Avenue.

Block Grant Funds are made available to the City of Las Vegas under Title I of the Housing and Community Development Act of 1974.

REHABILITATION MATERIALS

The Westside Community Development Comissions "Minor Home Repair Service Program" rehabilitated and applied 30,250 square feet of paint to the exteriors and interiors to homes of senior citizens in Vegas Heights since January 3rd this year.

All materials are provided by the Block Grant Rehabilitation Materials Program, and the work is done by three CETA program participants assigned to the WSCDC and five E.O.B. T.W.I.N.E. program enrollees.

All services and materials are free to qualifying senior and handicapped home owners.

New Ridership Service

Provided For The Handicapped

A new service to aid in the transportation of the handicapped has been introduced to the area through the combined efforts of the Las Vegas Transit System, Nevada State Bank and the Southern Nevada Committee on Employment of the Handicapped.

The service provides for reduced one-way fares of 20¢ on all Transit company buses throughout the system.

In order to be eligible, certification of moderate to severe handicaps is required. Upon certification, applicants will be photographed free of charge for necessary identification cards at the main branch of Nevada State Bank at Fourth and Carson Streets any time during the normal banking hours. Photographs cannot be processed unless applications are on approved, prescribed

Applications, or "ridership forms," must be signed by a physician or a duly authorized representative of a public or non-profit agency representing the handicapped.

Incomplete or questionable applications will be reviewed by the Southern Nevada Committee on Employment of the Handicapped. Bank and Transit company personnel may not rule on eligibility nor may either firm act as sources for the required application forms.

Completed identification cards, with photo furnished by the bank, must be presented to the bus driver upon boarding the vehicle.

The program makes it possible for many employed and unemployed handicapped persons to commute either to their jobs or to various centers where they are receiving special training or treatment.
