The above-named City proposes to request the U.S. Dept. of Housing and Urban Development (HUD) to release Federal funds under Title I of the HUD Act of 1974 (PL 93-383) to be used for the following project:

It has been determined that such request for release of funds will not constitute an action significantly affecting the quality of the human environment, and, accordingly, the above named City has decided not to prepare an Environmental Impact Statement under the National Environmental Policy Act of 1969 (PL 91-190).

The reasons for such decision not to prepare such Statement are as follows: **THE PROJECT IS NOT AN ACTION SIGNIFICANTLY AFFECTING THE QUALITY OF HUMAN ENVIRONMENT.**

An Environmental Review Record respecting the within project has been made by the above-named City which documents the environmental review of the project and more fully sets forth the reasons why such Statement is not required. This Environmental Review Record is on file at the above address and is available for public examination and copying, upon request, between the hours of 7 am and 6 pm.

No further environmental review of such project is proposed to be conducted, prior to the request for release of Federal Funds.

All interested agencies, groups and persons disagreeing with this decision are invited to submit written comments for consideration by the City to the office of the Mayor, P.O. Box 4086. Such written comments should be received at the P.O. Box on or before Feb. 1, 1979. All such comments so received will be considered and the City will not request the release of Federal funds or take any administrative action on the within project prior to the date specified in the preceding sentence.

BLACK EMPOWERMENT

WHO'S TO BLAME

So much of the literature concerning the peculiarly American institution of human enslavement is so defensive in its orientation that we may find it difficult to gain at times an accurate picture of conditions surrounding black American enslavement from even the most scholarly literature.

Nonetheless, some lines or aspects of the situation are becoming increasingly clear...and highly illuminating, as well.

One such picture or element consists in the probable fact that there were far more poor whites in exceedingly wretched conditions than we generally imagine or reckon. This is not to compare, in any way, the conditions of degradation and of emasculation in human enslavement with any of the deprivations of freedom. Still, from a purely economic, from a purely educational or from a purely skills and/or value-oriented point of view, very narrow, limited or discrete comparisons may be made.

Some of the best estimates today suggest that black impoverishment at the time of black Emancipation differed in degree not too greatly from the same conditions relative to white Americans today. Today black unemployment generally doubles just about the rate of white unemployment and approxi-

mately trebles that of whites among young people.

So far as skills were concerned, many blacks historically were in a relatively favored condition in comparison to poor whites, at least until the influx of European skilled labor beginning in the second quarter of the 1800's. Because blacks traditionally served—and hence were close to—the rich, black values and aspirations, as well as black general cultivation often tended to be proportionately higher than in these same elements among the poor white.

The picture painted or sketched here is thoroughly consistent with an emerging view today; namely, that the hitherto unclosed and presently unclosing gap between social and economic conditions of black Americans and the American mainstream (or white America) may be somewhat near, or perhaps even more, than a century old.

Regardless of the absolute accuracy of the statistics which may underlie the situation outlined here, all would doubtless agree that—from the reasonably accurate statistics of half a century—the social and economic condition of blacks in comparison to that of white Americans has remained an unchanging one. This has potentially disastrous implications for the nation.

We cannot long remain at peace internally, so the historic Kerner-Commission Report of a decade ago warned, so long as we maintain two societies, one white and one black, one educationally much more privileged and the other disproportionately disadvantaged in this area, and one which is affluent in large measure while the other "largely survives" in a condition of relative poverty.

The Kerner Commission was thorough in its description of the glaring inequities which the black community in America faces every day. Prescriptions were made chiefly for "more quantities of the same remedies" which had been applied in the past. These remedies, as Dr. Charles Hamilton of Columbia University so aptly noted, were primarily relief-oriented.

They called for the "giving of more handouts" to black Americans when, in fact, black Americans have needed, perhaps foremost, guaranteed and equitable opportunity in every aspect of our nation's life. Secondly, blacks have needed another ingredient not stressed by the 1968 Kerner Commission Report but noted, perhaps for the first time in white literature written regarding black America, in Gunnar Myrdal's *An American Dilemma* in 1942.

Myrdal noted in 1942 that one of the most essential ingredients for paving the road to progress for black Americans was what he called their own "social power."

More guaranteed "equity and restitution"—or "just" opportunity—which can and should be initiated by white Americans and by all Americans of good will and good sense who are concerned for the nation's continued prosperity and orderly progress) places a distinct burden upon white Americans, simply because they comprise the majority of those with a long-term stake in the nation's life. It is "equity and restitution" which is the basic or underlying issue in what promises to be the ongoing Bakke Case debate.

But as for "social power," this must be developed—although possibly catalyzed and encouraged by others—by blacks themselves. Just as long as blacks remain divided and isolated from one another, as in the past, in terms of failing to develop and exercise their own inherent group power, just so long will the gap between them and mainstream America remain unclosed...and the nation's internal peace also remain imperilled.

Dr. George Earnhart of Carson City, Nevada was elected vice president of the Nevada State Board of Education at the Board's organizational meeting. He succeeds David Hansen of Reno. Rosemary K. Clarke of Las Vegas was installed as president of the Board.

Earnhart, 41, has served on the Nevada State Board of Education since elected in 1976 from District 3b (Carson City, Churchill, Douglas, Lyon, Pershing, and Storey counties). He has been very active on the Board and has special interests in professional management development and counseling. He was recently honored by the Nevada Personnel and Guidance Association "In recognition and appreciation for outstanding contributions to the counseling profession in Nevada."

Dr. Earnhart is employed as a psychologist with the Nevada State Personnel Division and has long been active in community affairs. He is also currently serving as president of the board of directors of the Family Counseling Service of Northern Nevada. Earnhart was born in Fallon and has been a life-long resident of the state.
