

Dear Editor,

The North Las Vegas Police left a notice on the front door, to contact a detective Ed Blysner in Spokane, Washington, in regards to son Robert Jimerson. The note was left on the front door Tuesday night, February 6, 1979. The following morning officials at the county jailwere contacted in Spokane after many calls without success. Robert's mother Lottie tried but couldn't get through, being upset not knowing what was the situation, she called one of her daughters to come over to help her. When her daughter came she got through but the party on the other end of the phone said that he had nothing to do with matter and that he was affiliated with the military, and he just answered the phone because no-one else was there. So Mrs. Jimerson left her number with that source, and left the message to be contacted by the jail officials. The call later was returned and the officer inquired of who was on the other end and of what relation they were, Robert's mother allowed her daughter Margie to take the call because of the effect of the waiting to be contacted uninformed.

The officer EdBlysner informed my sister that my brother, had committed suicide, this which struck her in such a way that she dropped the phone and the conversation was discontinued. When I got home and opened the door I heard My mother crying, so I asked what's the matter, and she replied Dwight Robert's dead, I replied, WHAT, she said Robert's dead, keeping my calmness I found out where he was and the individual to talk to concerning the case. Upon this I contacted Ed Blysner, Detective, County Jail, in Spokane, Washington in which he informed me that my brother had suppossedly committed suicide, by tieing a sheet around the cell bars and hanging

himself.

The officer informed me that he had been in jail since December on a second degree burglary charge, and had not yet been brought to trial Mr. Blysner stated that he was in the cell himself.

Also the FBI was contacted here, and they informed me that they could do nothing but to contact the office in Spokane. When this was done the FBI spokesman there stated, that he saw no reason to get in the case and that I needed to give him a reason to investigate the case. . . So

that's the law.

The situation seems somewhat hopeless, and if did not have the divine promise from Jehovah God, to rely on, I would have to throw my hands up in despair, but as God's word assures man-kind at Psalms 37:8-11 "Let anger alone and leave rage; Do not how Yourself heated up only to do evil. For evildoers themselves will be cut off, But those hoping in Jehovah are the ones that will possess the earth. And just a little while longer and the wicked one will be no more; And You will certainly give attention to his place, and he will not be. But the meek ones themselves will possess the earth, and they will indeed find their exquisite delight in the abundance of peace. Also Proverbs 24:12 tells us "In case you should say 'LOOK' We did not know of this, "will not he himself that is making an estimate of hearts discern it, and he himself that is observing your soul know and certainly. Pay Back to earthling man according to his activity?
