

west las vegas has second credit unio

The West Las Vegas community hailed the advent of a second Credit Union in its environs, this week. The Sara Allen Credit Union received its charter earlier this month and the Board of Directors invited the public to a meeting, Saturday to, announce the Credit Union will go into immediate operation at 820 West Bonanza Rd., Suite C. & D. The field of membership for the Sara Allen Credit Union is the Allen Chapel Associate Mem-bership, an official membership of the International A.M.E. Church.

The Credit Union is a project of Allen Chapel A.M.E. Church's Missionary Society. The Rev. Albert Dunn is pastor of Allen Chapel, and the Credit Union is named for the wife of the first A.M.E. Minister. Jean Dunn, wife of Rev. Dunn, is President of the Board of Directors. Mrs. Dunn is Education Services Director for the Economic Opportunity Board of Clark County for the Economic Opportunity Board of Clark County, responsible for that agency's Head Start and Day Care She is noted as an outstanding ad-Programs. ministrator. Other Board members are Senator Joe Neal, Rev. Walter E. Coleman, Glodine Sawyer, William Stewart, Willie J. Neely, and Joyce Broussard.

Mary Stewart, Barbara Curtis and Willie Neal com-prise the Credit Committee and serving as Supervisory Committee members are Eugenia P. Orenschall, Attorney for the Credit Union, Ruby Payne, Monroe Williams, Mary Wesley, and Eldora West.

Mrs. Dunn noted it took nine months of determined effort and total commitment from members of the Missionary Society to see this fruition of their dream. She added "We hope to provide another avenue for Las Vegas residents of the Black community to utilize benefits of a community-based financial institution."

CORONERS' INQUESTS

"NOT GUILTY"

A three-member jury cleared security guard Jerry Rudd, Tuesday, of wrongdoing in the shooting death of John Oscar Dupre, 54, in the first public inquest held in Clark County since 1976.

Dupree was shot and killed August 16 at Jerry's Nugget Casino in North Las Vegas when, according to witnessesses' testimony at the inquest, Dupree drew a knife on Rudd and fellow security guard, Bob Siller, as the guards tried to remove him from the casino.

On Wednesday, a Coroner's Inquest into the July 26 shooting of Varner Coleman, 27, of Alamagordo, New Mexico by Metro police officers also resulted in a finding of no criminal negligence.

District Attorney Robert Miller revived the Coroner's Inquest after the Clark County Ministerial Alliance protested closed door investigations of police shootings as occur when such investigations are conducted by a grand jury

Senator Joe Neal, who was selected as spokesman by the Ministerial Alliance during the recent controversy over recent shootings of civilians by police, said that the Alliance is pleased that Clark County has reverted to the Coroner's inquest system in such cases, but are more convinced than ever that a special prosecutor should be brought in for these inquests.
