To the surprise of the 600 guests in the East Room, and the utter delight of the NAACP Counsul and his wife, Lillian, Mr. Carter announced Jones' appointment.

Afterward, from his home in Teaneck, New Jersey, Attorney Jones commented that had he not been working for the NAACP, in all probability he would not have gained the recognition that was crucial to his niversary celebrations of the Brown vs Board of

not have gained the recognition that was crucial to his appointment. He would have been like thousands of other black lawyers working unrecognized. But, because of the immense prestige of the organization and the opportunity it gave him to display his talents, he will be joining the ranks of such former noteworthy NAACP lawyers as Supreme Court Justice Thurgood Marshall and U.S. District Judge Robert
