## CITY OFFICIALS TO PAY TRIBUTE TO REV. PRENTISS WALKER

**NEVADA'S BLACK** 

COMMUNITY NEWSPAPER NOW IN OUR 16TH. CONSECUTIVE YEAR



Members of the predominantly black community of West Las Vegas will pay tribute Sunday to the late Rev. Prentiss Walker, a staunch civil rights activist for more than 20 years.

The ceremony will be at 2:30 p.m. at Rev. Walker's former parish, the Greater Faith Baptist Church at 2736 Chamberlain Lane.

Michael L. Himes, a former associate of Walker's, will be the keynote speaker.

This will be the second tribute in as many years for Walker, arranged by Edward Smith.

Smith said, "We are trying to make the tribute an annual event because of what he did when he was alive."

Walker was one of the spearheaders of the movement in the 1960s which led to the intergration of Downtown Las Vegas and the Strip, according to Smith.

While employed at the Nevada Test Site in 1960 as a carpenter, he filed a discrimination suit against the facility which eventually led to the hiring of more blacks, Smith said.

Walker, who died in 1977 at the age of 66, came

He was the first black member on the State Democratic Central Committee, and the first black to be admitted to the local carpenter union.

He was a former president of the local chapter of the Southern Christian Leadership conference.

## **FEDS SUE SEARS**

WASHINGTON - The federal government filed five suits Monday against Sears, Roebuck and Co., charging the world's largest retailer with discriminating against women, blacks and Hispanics.

The filing of the suits in New York City and four other cities marked the latest round in the Equal Employment Opportunity Commission's nearly seven-year investigation into Sears' employment practices.

Sears had tried earlier this year to stop all federal enforcement of job discrimination laws by filing suit against EEOC and nine other federal agencies, contending that the government's policies - such as veterans' preference laws - had created an "unbalanced workforce" dominated by white males.

The Sears' suit was dismissed in federal district

In the nationwide suit filed in Chicago, headquarters of the company, the commission accused Sears of paying women less than men in similar jobs; of engaging in sexually discriminatory recruiting, hiring, training, and promotion practices, and of giving lesser employment opportunities to pregnant employees.

ployment opportunities to pregnant employees. In the suits, the commission asked for injunctions to prevent Sears from engaging in discriminatory practices against minorities and women. The suits also ask for affirmative action programs to eliminate unlawful employment practices and for back pay with interest for those persons who have been adversely affected.

In a statement issued in Chicago, officials of Sears, Roebuck said:

"We welcome this opportunity for a fair hearing before the courts, something we have not had in six years of dealing with the staff of the EEOC.

"We are proud of our record in affirmative action and we agree with the attorneys for the EEOC itself who said recently: 'Sears has been in the vanguard of voluntary affirmative action since 1974 and with respect to minorities, possibly as early as 1969.""

Sears officials said Monday that, by the end of the year, 19.9 per cent of all Sears employees were from minority groups, up from 8.7 per cent in 1965; 10.9 per cent of Sears officials and managers were minorities up from 1.4 per cent in 1965; and 37 per cent of Sears officials and managers were women, up from 20 per cent in 1965.

Sears, Roebuck employs more than 400, 000 people in its more than 3, 700 stores or catalogue distribution centers in all 50 states and Puerto Rico.

After a four-year investigation into Sears' hiring practices, the EEOC voted in the spring of 1977 to charge the company with "patterns of sex, race and national origin discrimination at all levels." Efforts to negotiate a settlement broke down earlier this year.
